RECOMMENDATION(S):

That the Board of Supervisors:

1. Receives and files the bids for the Central Avenue (4L800) Highway Safety Improvement Project from Anna Sparks Way to Hiller Road.
2. Awards the contract to Mercer-Fraser Company for the Base Bid, Additive Option A, and Additive Option B for the total amount of \$927,381.
3. Authorizes the Chairman to execute the project agreement upon submittal of the appropriate bonds and insurance.
4. Directs the Auditor-Controller to establish a new contract account 1200321-0321 and transfer \$985,396 from 1200321-2118 to the new contract account per the attached appropriation transfer.

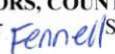

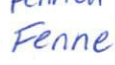

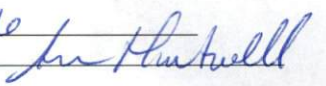

DISCUSSION:

On March 8, 2016, the Board of Supervisors authorized the Clerk of the Board to advertise the above-referenced project for bids. On April 19, 2016, the County received two (2) bids for the project. The results are as follows:

1. Mercer-Fraser Company, Eureka, CA	Base Bid	\$ 790,364.00
	Additive Option A	\$ 2,600.00
	Additive Option B	\$ 134,417.20
2. Wahlund Construction, Inc., Eureka, CA	Base Bid	\$1,028,072.62
	Additive Option A	\$ 1,800.00
	Additive Option B	\$ 137,498.40

Anticipated construction costs for the project are as follows:

Construction (Base Bid + Additive Option A + B)	\$ 927,381.00
Contingencies (5%)	\$ 46,396.00
Subtotal	\$ 973,750.00
Construction Administration (15%)	\$ 146,063.00
TOTAL	\$1,119,813.00

FINANCIAL IMPACT:

This project, which stretches from Anna Sparks Way to Hiller Road, is being funded through the Federal Highway Administration, which will provide ninety percent (90%) of the construction costs with a ten percent match (10%) from the County. Total project cost is estimated at \$1,119,813, of which \$985,396 is already included in the FY 2015-16 Roads – Engineering budget 1200321. Additive Option B will apply a slurry seal to resurface the existing pavement on Central Avenue from Anna Sparks Way to Pickett Road at a cost of \$134,417, which will be paid with FY 2015-16 Measure Z funds.

This project conforms to the Board of Supervisors' Core Role of providing and maintaining infrastructure.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

Not award the project; however, staff does not recommend this alternative as this project will improve Central Avenue using funds that would not otherwise be available to the County.
