**RESOLUTION FOR EXCEPTION TO THE 180-DAY WAIT PERIOD GC SECTIONS 7522.56 & 21221(h)**

**WHEREAS**, in compliance with Government Code section 7522.56, the Humboldt County Board of Supervisors must provide this certified Resolution to the California Public Employees Retirement System (CalPERS) when hiring a retiree before 180 days has passed since their retirement date; and

**WHEREAS**, Brooke Epperly is retiring from Humboldt County Public Works Department as an Executive Secretary, effective January 26, 2024; and

**WHEREAS**, section 7522.56 requires that Ms. Epperly's post-retirement employment commence no earlier than 180 days after retirement date, which is January 26, 2024, without this certified Resolution; and

**WHEREAS**, section 7522.56 provides that this exception to the 180 day wait period shall not apply if the retiree accepts any retirement-related incentive; and

**WHEREAS**, the Humboldt County Board of Supervisors, the Humboldt County Public Works Department and Ms. Epperly certify that Ms. Epperly has not and will not receive a Golden Handshake or any other retirement-related incentive; and

**WHEREAS**, an appointment under Gov. Code section 21221(h) requires the retiree is appointed into the interim appointment during recruitment for a permanent appointment; and

**WHEREAS**, the governing body has authorized the search for permanent appointment on 10/06/23; and

**WHEREAS**, the County of Humboldt hereby appoints Ms. Epperly as an interim appointment retired annuitant to the vacant position of Executive Secretary for the County of Humboldt Public Works Department under Gov. Code section 21221(h), effective 2/5/24; and

**WHEREAS**, this Gov. Code section 21221(h) appointment shall only be made once and therefore will end on the day prior to an incumbent filling the position; and

**WHEREAS**, the entire employment agreement, contract or appointment document between Ms. Wittenberg and the County of Humboldt has been reviewed by this body and is attached herein; and

**WHEREAS**, the employment shall be limited to 960 hours per fiscal year; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

**WHEREAS**, the maximum base salary for this position is \$ 5,398.62 per month and the hourly equivalent is \$31.15 and the minimum base salary for this position is \$4,207.07 per month and the hourly equivalent is \$24.27; and

**WHEREAS**, the hourly rate paid to Brooke Epperly will be \$31.15.
