RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE HUMBOLDT COUNTY DEPARTMENT OF HEALTH AND HUMAN SERVICES TO APPLY FOR AND, IF AWARDED, ACCEPT FUNDING MADE AVAILABLE THROUGH THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT'S CALIFORNIA EMERGENCY SOLUTIONS GRANTS PROGRAM — CORONAVIRUS ROUND 2

WHEREAS, on October 2, 2020, the California Department of Housing and Community Development ("HCD") issued a second Notice of Funding Availability ("NOFA") under the Coronavirus Aid, Relief, and Economic Security Act allocation to the Emergency Solutions Grants Program ("ESG-CV Program"), hereinafter referred to as "ESG-CV Round 2;" and

WHEREAS, the County of Humboldt ("County") is a state approved Administrative Entity that previously received ESG-CV Program funding under the initial NOFA dated June 1, 2020, hereinafter referred to as "ESG-CV Round 1;" and

WHEREAS, HCD may approve funding allocations for ESG-CV Round 2, subject to the terms and conditions of the NOFA dated October 2, 2020, ESG-CV Program regulations and requirements and the State of California Standard Agreement ("State Standard Agreement"), as well as any other applicable agreements, between HCD and recipients of ESG-CV Round 2 funding.

## NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The County hereby certifies and represents that all information submitted on its ESG-CV Round 1 application remains true, correct and accurate, or HCD has approved, in writing, any changes to the County's ESG-CV Round 1 application.
- 2. The County hereby affirms its continued compliance with all of the terms and conditions of its ESG-CV Round 1 application and the related State Standard Agreement.
- 3. The Humboldt County Department of Health and Human Services ("DHHS") is hereby authorized and directed to apply for and, if awarded, accept ESG-CV Round 2 funds in accordance with the terms and conditions of the NOFA dated October 2, 2020 and any and all applicable local, state and federal laws, regulations, requirements and standards.
- 4. If the County's application for ESG-CV Round 2 funding is approved by HCD, the Humboldt County DHHS Director, or a designee thereof, in the event that sufficient evidence of designation is provided to HCD, is hereby authorized and directed to enter into, execute and deliver, in accordance with any and all applicable local, state and federal laws, regulations, requirements and standards, a State Standard Agreement for an amount not to exceed Four Million Five Hundred Thousand Dollars (\$4,500,000.00), and any amendments thereto, along with any other documents required or deemed necessary to accept and secure the ESG-CV Round 2 funding and the County's obligations related thereto.
- 5. If the County's application for ESG-CV Round 2 funding is approved by HCD, the County hereby represents and certifies that all such funding will be used in a manner consistent, and in compliance, with any and all applicable local, state and federal laws, regulations, requirements and standards, including, without limitation, any and all applicable laws, regulations, requirements and standards regarding the ESG-CV Program, as well as any and all applicable agreements between the County and HCD.
