We are currently in a historic drought which is impacting the entire county, a drought that the Board of Supervisors has acknowledged. Water is becoming more scarce, and should be conserved tor existing residential property owners. What will we do when our wells run dry? People who move to Kneeland to put in a giant grow and make a crazy profit will not care, Who will we send the bills to when our wells run dry and we need to truck in water? The environment will be impacted with the use of herbicides, rodenticides, pesticides, etc. These chemicals will leach into ground water and contaminate wells and or creeks that don't dry up. Our roads are not engineered for the extra traffic that this grow will bring,, the road is already awful and with more vehicle and large truck traffic it will further degrade. Not to mention the aggressive drivers that care absolutely nothing about residents, pets, or wildlife that will also be on the road for various reasons. Our property values will be impacted by this as well.
