RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT, ADOPTING THE SECOND AMENDMENT TO THE HEADWATERS FUND MASTER PARTICIPATION AGREEMENT WITH ARCATA ECONOMIC REDEVELOPMENT CORPORATION

WHEREAS, on December 17, 2002, the Board of Supervisors of the County of Humboldt ("County") adopted Ordinance 2289, Management of the Headwaters Fund, codified in Humboldt County Code §§ 2151-1 through 2151-5 (the "Charter") whose purpose, in part, is supporting the growth of base industry clusters and increasing the number of sustainable jobs that pay near or above the median income in the County; and

WHEREAS, the County and Arcata Economic Development Corporation ("AEDC") have previously entered into agreements for AEDC to act as a lender for the Headwaters Fund pursuant to a Master Participation Agreement (the "Agreement"); and

WHEREAS, as businesses located in Humboldt County have been adversely impacted by the COVID-19 pandemic, the County and AEDC amended their Agreement to provide more streamlined and relaxed lending guidelines with the goal of permitting AEDC to offer more local business loans more quickly during the pandemic; and

WHEREAS; Humboldt County Code §2151-3(f) sets forth that the Board of Supervisors approves the contracts with financial institutions having access to Headwaters Fund; and

WHEREAS, County and AEDC (the "Parties") now desire to amend the Agreement again to revise certain provisions and provide greater clarity and ease in administering the Agreement with the Board of Supervisor's approval.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY OF HUMBOLDT BOARD OF SUPERVISORS AS FOLLOWS:

- **Section 1.** The Second Amendment to the Master Participation Agreement with AEDC is approved.
- **Section 2.** The Second Amendment to the Master Participation Agreement is adopted to be effective as of May 31, 2022, and any acts that have occurred in the interim are hereby ratified.
