8.0 EVALUATION CRITERIA AND SELECTION PROCESS

After the Proposals are received and opened by the Sheriff's Office, the Sheriff's Office will review and evaluate all Proposals to this RFP. Evaluators will determine whether the Proposer possesses the qualifications necessary for satisfactorily completion of proposed patrol vessel and trailer. The Sheriff's Office may also investigate qualifications of each Proposer/Bidder to whom it is contemplating awarding. In doing so, the Sheriff's Office may request clarifications of Proposals directly from one or more Proposers.

9.0 SCORING

The Humboldt County Sheriff's Office review team will use a consensus approach to evaluate and score a weighted scorecard. Members of the review team will not score sections individually but, instead, will arrive at a consensus as to assignment of points for each of those sections. Criteria will be grouped in like categories and given a percentage based on importance. There are 5 categories totaling 100% overall. Each line within the category will be weighted by a percentage totaling the whole of the category. Points will be given to each line and multiplied by the weighted percentage assigned to that line within the category. Scoring will be: 10=Fully Meets Objectives, 7=Mostly Meets Objectives, 3=Partially Meets Objectives, and 0=Not Suitable. Once all points are assigned, they will be multiplied by the weighted percentage creating a weighted total score. The highest weighted total score from all categories, and determination of fulfillment of needs criteria will determine the award.

In case of a tie the review team has determined that the tied vendors sealed bid response date, to the RFP, will determine the tie breaker. If there is a situation where there is a tie in the response delivery date for those tied vendors, then a random draw will take place to determine the vendor selected for the award.
