A RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS CALLING A SPECIAL ELECTION TO SUBMIT TO THE VOTERS OF HUMBOLDT COUNTY A PROPOSAL FOR THE ESTABLISHMENT OF AN OFFICE OF THE DIRECTOR OF FINANCE AND ORDERING THAT THE SPECIAL ELECTION BE CONSOLIDATED WITH THE STATEWIDE ELECTION TO BE HELD ON MARCH 5, 2024

WHEREAS, California Government Code Sections 26980, *et seq* provides that a county board of supervisors may establish the Office of Director of Finance by ordinance if approved by the votes of the county; and

WHEREAS, the County of Humboldt is dedicated to maintaining stringent fiscal accountability standards; and

WHEREAS, the County of Humboldt must ensure the Treasurer-Tax Collector and Auditor-Controller are professionally trained and qualified; and

WHEREAS, making only authorized, legal payments; ensuring timely, accurate property tax billing/payments; and posting monthly financial reports for public review are ongoing priorities for the county; and

WHEREAS, the County of Humboldt's offices of the Auditor-Controller and Treasurer-Tax-Collector currently function as independent offices led by officials elected by the voters of Humboldt County; and

WHEREAS, California Government Code Sections 26980, *et seq.* allows the Board of Supervisors to adopt an ordinance, following voter approval, creating an appointive Office of Director of Finance; and

WHEREAS, the Humboldt County Board of Supervisors wishes to submit a question to establish the Office of the Director of Finance to voters of the county on the March 5, 2024 ballot; and

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The Humboldt County Board of Supervisors hereby calls a special election to submit to the electors of Humboldt County whether the offices of the Auditor-Controller and Treasurer-Tax Collector shall be combined into an appointive Office of the Director of Finance, with a ballot question stated as shown in Attachment 1 to this resolution.
- 2. The date of the election shall be March 5, 2024, and the election shall be held solely within the boundaries of Humboldt County, for the purpose of allowing the voters in Humboldt County to vote on a measure described herein.
- 3. The election called by this resolution shall be, and is hereby ordered to be, consolidated with the statewide election to be held on March 5, 2024.
- 4. The Humboldt County Board of Supervisors hereby requests that the Humboldt County Registrar of Voters render any and all services specified under law, for which services the Board agrees to reimburse upon full presentation of a bill for such services.
