AMENDMENT TO DESIGN CONTRACT FOR MATTOLE

ROAD BRIDGE (04C-0055) OVER THE MATTOLE RIVER AT

HONEYDEW

<u>RECOMMENDATION(S)</u>: That the Board of Supervisors execute an amendment to the above referenced contract extending the completion date for consultant services.

SOURCE OF FUNDING: Road Fund - Federal Highways Administration Bridge Program and Proposition 1B – The Highway Safety, Traffic Reduction, Air Quality, and Port Security Act of 2006.

<u>DISCUSSION</u>: On January 24, 2012 the Board of Supervisors authorized the execution of a contract for design services for the Mattole Road Bridge (04C-0055) over the Mattole River at Honeydew.

The project has stalled in the development of the environmental documentation. It has been determined after initial study that more in-depth review and documentation will be necessary to comply with the environmental phase of this project. Preliminary engineering performed by our consultant has developed geotechnical and hydraulic studies and prepared preliminary design alternatives for environmental impact analysis. The consultant cannot complete the preliminary
