

SUBJECT: Zoning Ordinance Revisions. Medical Marijuana Land Use Ordinance Phase II
– Regulation of Neighborhood Impacts from Outdoor Cultivation on Small
Parcels. Case Number OR-14-001 Applies Countywide

ACTION: A motion was made to direct staff to bring back the ordinance with the
following modifications:

- On parcels one (1) acre or smaller, 100 square feet of canopy with a 20-foot
setback from the property line;
- On parcels greater than one (1) acre and up to 5 acres, 200 square feet of
canopy with a 40-foot setback from the property line;
- Allow the same canopy area within a secured greenhouse;
- Clarification about who has standing to complain, and ability to limit
complaints to owners of contiguous parcels;
- Additional clarification about an expedited abatement process;
- Prohibition on outdoor cultivation on undeveloped parcels in the Shelter Cove
subdivision.


