QUALIFICATIONS: Resident of Humboldt County.

**TERM:** Supervisor's appointees serve a 4-year term to run concurrent with the

term of office for each Supervisor.

Sheriff's appointee serves a 4-year term to run concurrent with the term

of office for the Sheriff.

HDSO President's appointee shall serve four years from the date of

appointment.

FUNCTION: Help educate the public on law enforcement policies and procedures of

the County Sheriff's Office.
