

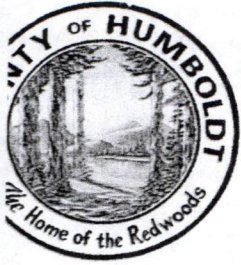
I have been a practicing CPA since 1984 until my retirement in 2014.
