### **DISCUSSION:**

At the March 9, 2015 meeting, the Board deliberated on Appendix B: Glossary and Definitions, Appendix C: Community Area Plans Policy Extract, Appendix E: Coastal Plans, and on the work plan for the upcoming Land Use Map workshops and meetings. The Board requested each of these items be brought back for further deliberation at the March 22<sup>nd</sup> meeting.

### Appendix B: Glossary and Definitions

A worksheet has been added to Attachment 1 to identify options for the Board's consideration of the possible additions and other changes to the glossary suggested by the public at the March 9 meeting:

- Add "Lot Line Adjustment"
- Add "Common Sense Clause" from policy
- Add "Grandfathered"
- Modify "Ad Hoc Working Group" (make more general)
- Add "Shall", "Should", "May"
- Modify "Alternative Waste Disposal" (get proposed revisions from Mr. Grover and give them to the Health Department for review)
- Modify "Community Plan" (add people to the definition)
- Modify "Development" (simplify)
- Differentiate man-made wetlands from other wetlands

#### Appendix C: Community Area Plans Policy Extract

At the March 9 meeting, the Board took public comment and began deliberations on Appendix C: Community Area Plans Extract (**Attachment 2a**). No straw votes were taken to provide more time for review of Appendix C.

There was considerable public discussion about the Avenue of the Giants Community Plan during the March 9<sup>th</sup> public hearing. Some members of the public believe the public participation for updating the Community Plan was flawed, and question its validity. A review of the project files suggests that this Community Plan was adopted consistent with state law with a rigorous public participation component that included community meetings, several Planning Commission hearings, and several Board of Supervisors hearings. Updating the Community Plan with additional public outreach may be initiated at the discretion of the Board of Supervisors.

Staff continues to recommend that this Community Plan be removed from Appendix C and kept as a separately bound document along with the Eureka Community Plan and the McKinleyville Community Plan. The modifications in **Attachment 2c** proposed by staff are needed to make the Community Plan consistent with the proposed General Plan.

For reference purposes, **Attachment 2b** compares the existing Community Plans with Appendix C. **Attachment 2c** presents suggested revisions to the Avenue of the Giants, Eureka, and McKinleyville Community Plans to maintain consistency with the General Plan Update. **Attachment 2d** provides suggested modifications to the narrative in Chapter 2 to clarify the relationship between Community Plans and the General Plan, prior adopted General Plan Elements and the proposed Plan. Planning staff provided each attachment as an individual electronic file to make the documents easier to retrieve from the County's website.

#### **Coastal Plans**

Staff transmitted the straw-voted GPU chapters to local Coastal Commission staff on Thursday, March 5, 2015. Coastal Commission staff will review each policy, standard, and implementation measure, and insert those that are applicable into each LCP. The draft LCPs will then be reviewed and approved by the Board of Supervisors and officially transmitted to the Coastal Commission for approval. The Land Use maps will also be transmitted to local Coastal Commission staff for review once they are straw-voted by the Board. No action by the Board is needed at this time for the update of the coastal plans.

### Land Use Mapping Workshop and Meeting Work Plan

Staff met with three Board members on March 11, 2015 to review the Planning Commission recommendations for the General Plan Land Use maps, and to identify workshop sites. Staff will be continuing that conversation with the remaining Board members on Thursday, March 26, 2015 The table below summarizes meeting locations, dates, and the overall schedule for the land use mapping effort.
