### RECOMMENDATION(S):

That the Board of Supervisors approves the change in open hours for the HCPD as specified on Attachment 1 to accommodate construction and water damage clean-up efforts.

#### SOURCE OF FUNDING:

General Fund

#### **DISCUSSION:**

Traditionally, the Humboldt County Public Defender is open to the public Monday-Thursday from 8:30 am-12:00 pm and 1:00 - 5:00 pm. The telephone hours are Monday - Thursday (M-TH) from 10:00 am - 12:00 pm and 1:00-4:00 pm. The Public Defender office is closed to the public on Fridays.

On March 23<sup>rd</sup> the water heater on the second floor of the building located at 1001 4<sup>th</sup> Street was found to have a leak, creating water damage to the ceiling and carpet on the 1<sup>st</sup> floor. It was discovered that the water damage was much more extensive than originally thought and flooring needed to be removed in the 2<sup>nd</sup> floor break room and the 2<sup>nd</sup> floor women's restroom.

It was also discovered that the sheetrock in the ceilings and walls between the interview room and women's restroom on the 1st floor needed to be removed and that deep carpet cleaning was needed. One employee had to be relocated to an alternate location on the 5th floor of the courthouse that would have access for Public Defender clients who are disabled. Alternate locations were also created for the remaining downstairs staff within the building. The downstairs interview room that is effected is the room that the Public Defender attorneys use to see clients who cannot make it upstairs. Having fewer staff to greet clients, no access to files that are stored in the room, and no interview room to meet clients downstairs has already placed a burden on the staff. Originally the reconstruction was expected to begin as early as April 16th however, construction has been delayed to the impacted areas. Once construction begins, the lobby to the Public Defender office is expected to be unavailable to the public because all staff will be temporarily relocated at that time.

The proposed temporary adjustment to the hours of operation would allow the overburdened remaining staff to increase their productivity until construction begins. Once construction begins, for the safety of the staff and public, the office will need to be closed to foot traffic, and will only be available by telephone and special set in person appointments when required at an alternate location that has access for disabled clients. The temporary hours would only be in effect until construction and clean up ended, currently estimated to be less than 30 days. When the employees are able to return to their downstairs locations with public access the hours would return to the normal hours of operation.

#### **FINANCIAL IMPACT:**

Approval of the shift in open hours would not increase costs nor decrease costs for the Public Defender office.
