Subject: Supplemental Budget for Fiscal Year 2014-15

**RECOMMENDATION(S)**:

That the Board of Supervisors:

1. Approve the fiscal year (FY) 2014-15 Supplemental budget shown on Attachment 1 for the District Attorney's Office. (4/5 Vote)

SOURCE OF FUNDING:

General Fund

DISCUSSION:

Costs in various accounts under control of the District Attorney's Office were higher than originally budgeted for FY 2014-15. The requested action is needed to adjust the budget to reflect actual expenditures and revenues for last fiscal year.

The District Attorney's Office was under budgeted for FY 2014-15 in services and supplies. Books and Periodicals expenditures were higher than budgeted due to the need to purchase books for new hires as well as updating the law library. In past years due to the limited budget legal materials were discontinued and the law library periodicals became outdated. Additionally, the Office has experienced increased costs for

Funds will be covered by DA Seized Funds which are from asset forfeiture.

#### FINANCIAL IMPACT:

This request will have no impact on General Fund contingencies. Increased revenues need to be recognized in the identified account to allow for increased expenditures. The requested supplemental budget will adjust the overall District Attorney budget up by \$17,200.00.
