Subject: ELIMINATE ONE ALLOCATED AND FUNDED ROAD MAINTENANCE WORKER II AND ADD ONE TRAFFIC CONTROL MAINTENANCE WORKER IN ROADS MAINTENANCE-BUDGET UNIT 325

RECOMMENDATION(S): That the Board of Supervisors eliminates one allocated and funded FTE Road Maintenance Worker II (RMW II) in crew seven, position number 325238B26 (Class 238) and adds one FTE Traffic Control Maintenance Worker (TCMW) in crew seven, position number 3250220-04 (Class 220), effective at the beginning of the next biweekly pay period following approval.

SOURCE OF FUNDING: Road Fund -1200325

DISCUSSION: Public Works has received the resignation of the RMW II assigned to crew seven effective July 31, 2015. After analysis of the Roads Maintenance staffing needs in the current fiscal year, it is recommended that this RMW II position be eliminated and replaced with a TCMW in crew seven. Crew seven is responsible for signing and striping of roadways. One function of a TCMW is driving and operating specialty equipment to stripe county roads. This change will align the functions of the position to meet the needs of the crew.

This action supports the Board's Strategic Framework by providing for and maintaining infrastructure.


