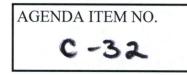

Subject: Fiscal Year 2015-16 Budget Adjustment Request for Humboldt County Correctional Facility Budget Unit 243 for Upgrades to Security System

Approve the attached budget adjustment for Budget Unit 243 Humboldt County Correctional Facility (Jail) to transfer funds from Maintenance - Equipment expense item and establish a fixed asset expense item in fiscal year budget 2015-16 to facilitate upgrades to the Jail security system.

DISCUSSION:

In October 2001 Humboldt County invested in a computerized security system for the Jail. The original cost of the complete system was \$237,902. The current version of "Cimplicity" software running the Jail security system requires Windows 7 and Windows Server 2008 compatibility, however, the County's existing security system will not run on Windows 7 or Windows Server 2008 software and is no longer able to support the addition or replacement of any new computer units.

Upgrades to the existing system will not only modernize the system, it will allow for a spare touch screen and one spare work station as a contingency in case of a downed unit. The upgrade also includes a three-year warranty period in coordination with the Dell computers.

FINANCIAL IMPACT:

A budget adjustment in the amount of \$55,000 is requested to transfer funds already budgeted in the approved FY2015-16 budget for the Humboldt County Correctional Facility budget unit 243 under Maintenance – Equipment (1100-243-2112) to the fixed asset line item. This transfer will cover upgrades as described below and requires no additional contribution from the General Fund.
