

Continuation of Emergency - Prolonged Drought in Humboldt County.

<u>RECOMMENDATION(S)</u>: That the Board of Supervisors declares that a local state of emergency, per Resolution #15-116, remains in effect until January 5, 2016, related to prolonged drought in Humboldt County.

SOURCE OF FUNDING: N/A

<u>DISCUSSION</u>: On July 15, 2014, the Board of Supervisors adopted Resolution # 14-59, which declared a local state of emergency related to prolonged drought in Humboldt County. On August 12, 2014, September 9, 2014, October 7, 2014, November 4, 2014, December 2, 2014, December 16, 2014, January 13, 2015, February 10, 2015, March 10, 2015, April 7, 2015, May 5, 2015, June 2, 2015, June 23, 2015, July 21, 2015, August 18, 201, September 15, 2015, October 13, 2015, and November 10, 2015 the Board determined that the emergency still existed and extended the emergency, per Resolution #15-116 through December 8, 2015. It has been determined that the emergency still exist and that the emergency should remain in effect for an addition twenty-eight (28) days, until January 5, 2016.

RESOLUTION NO. 15-119

RESOLUTION EXTENDING THE EXISTENCE OF A LOCAL EMERGENCY

WHEREAS Ordinance No. 2447 of the County of Humboldt empowers the Board of Supervisors to proclaim the existence or threatened existence of a Local Emergency when said county is affected or likely to be affected by a public calamity; and

WHEREAS, conditions of extreme peril to the safety of persons and property did arise within this county, caused by severe prolonged drought in Humboldt County and throughout California (fire, flood, storm, epidemic, riot, earthquake, drought, energy shortage, or other causes) commencing on or about July 15, 2014; and

WHEREAS, the Board of Supervisors of the County of Humboldt did proclaim the existence of a Local Emergency within the county on July 15, 2014; and

WHEREAS, the aforesaid conditions of extreme peril continue to exist and necessitate the continued proclamation of the existence of a Local Emergency.

NOW THEREFORE IT IS HEREBY PROCLAIMED AND ORDERED that said Local Emergency shall be deemed to continue to exist throughout said county as prescribed by state law, by (charter) ordinances, and resolutions of this county, and by the County of Humboldt Emergency Operations Plan, as approved by the Board of Supervisors on 25 June 2002, until its termination is proclaimed by the Board of Supervisors of the County of Humboldt, State of California.
