

WHEREAS, on January 6, 1992 Doug was promoted to Equipment Superintendent; and

WHEREAS, Doug has served in the capacity of Public Works Equipment Superintendent for over twenty-three years; and

WHEREAS, throughout his career, Doug has obtained numerous certifications in equipment operations and mandated County training courses; and

WHEREAS, Doug has continued to keep our fleet of vehicles and equipment updated and in compliance with Federal and State regulations.
