In 1990, the State of California established the California Recycling Market Development Zone ("RMDZ") program for the purpose of stimulating the recycling of waste materials generated in California. Local communities, separately or in partnership, apply for designation as an RMDZ.

The California RMDZ program is an economic and technical assistance program consisting of state-funded low interest loans, engineering and technical assistance, siting and permitting assistance and assistance with obtaining recycled feedstock. It is available primarily to those manufacturers who use recycled feedstock to make new products. Assistance is provided by local zone administrators, and local government incentives may include streamlined local permit processes, reduced taxes and licensing and increased and consistent secondary material feedstock supply.

In 1992, the Humboldt Recycling Market Development Zone ("Humboldt RMDZ"), which included designated areas within the unincorporated area of Humboldt County and the cities of Arcata, Blue Lake, Eureka, Ferndale, Fortuna, Rio Dell and Trinidad, was established. The Humboldt RMDZ was initially administered through the Humboldt County Department of Health and Human Services – Environmental Health ("DHHS – Environmental Health").

In 2002, an agreement was executed between the County and the Humboldt Waste Management Authority ("HWMA") under which HWMA agreed to provide staff services for the administration of the County's solid waste franchise contracts and rural container site program. HWMA also agreed to assume the County's AB 939 reporting responsibilities and manage certain programs administered by DHHS – Environmental Health, including the household hazardous waste program and the Humboldt RMDZ. Pursuant to the agreement between the County and HWMA, the Humboldt County Board of Supervisors designated HWMA as the zone administrator for the Humboldt RMDZ in July of 2002.

In 2003 the Humboldt RMDZ was expanded to include Del Norte County and Crescent City, and renamed the North Coast Recycling Market Development Zone ("North Coast RMDZ"). The North Coast RMDZ has helped support existing and new local recycling-based manufacturing businesses by allowing such businesses to be eligible for the technical and financial incentives associated with the California RMDZ program.

As part of this effort, the jurisdictions within the North Coast RMDZ help to facilitate local and regional recycling market development, planning and coordination and attract private sector recycling investments. Through these collaborations the North Coast RMDZ has helped create current and proposed waste management practices and conditions that are favorable to the development of post-consumer and secondary waste materials markets. The continued development of local markets for recycled materials will reduce the need to transport such materials out of the north coast region in the future.

Pursuant to the requirements of the California RMDZ program, an RMDZ must be re-designated by the California Department of Resources Recycling and Recovery ("CalRecycle") on a periodic basis. This process includes the filing of a re-designation application and resolutions re-affirming each jurisdiction's participation in the California RMDZ program with CalRecycle. Attachments 1-4 meet the requirements of CalRecycle to re-designate the North Coast RMDZ for an additional ten years.

Part of the re-designation process includes addressing all California Environmental Quality Act ("CEQA") requirements. Re-designation of the North Coast RMDZ will help protect the environment and preserve natural resources, and is therefore, categorically exempt from environmental review pursuant to Sections 15307 and 15308 of the CEQA Guidelines.

In addition, in order to perform services, Zone Incentive Funds applications are included as Attachment 5. The receipt of such funding will allow local representatives to attend conferences and allow for local outreach and marketing activities within the North Coast RMDZ.

#### FINANCIAL IMPACT:

The recommended action will have no direct financial impact to the County. Re-designation of the North Coast RMDZ will allow local recycling-based manufacturing businesses to continue to be eligible for the technical and financial incentives offered through the California RMDZ program.

Authorizing re-designation of the North Coast RMDZ conforms to the Board of Supervisors' core roles of encouraging new local enterprise, ensuring proper operation of markets and supporting business and workforce development, as identified in the Board of Supervisors' 2016 Strategic Framework.

#### ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could choose to not authorize the re-designation of the North Coast RMDZ. This alternative is not recommended because it would result in local recycling-based manufacturing businesses to be ineligible for technical and financial incentives made available through the California RMDZ program.

When the expansion/redesignation was completed, there was 342 hours for staff funded, plus there was DOC and other RMDZ grant funds available and received by this region. Steve Boyd, CIWMB regional staff, was active with additional hours of support and focus directly in the Humboldt RMDZ.

In 2015/16, There is 117.65 hours per year funded for RMDZ. No DOC grants or additional RMDZ grants available except for the ZIF funds (\$3,500) which may or may not add additional hours.

#### **RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS APPROVING THE FILING OF AN APPLICATION FOR THE RENEWAL OF THE NORTH COAST RECYCLING MARKET DEVELOPMENT ZONE**

WHEREAS, California Public Resources Code Section 42010 provides for the establishment of the Recycling Market Development Zone ("RMDZ") program throughout the State of California, which provides incentives to stimulate development of post-consumer and secondary materials markets for recyclables; and

WHEREAS, in 1992 the Humboldt Recycling Market Development Zone ("Humboldt RMDZ"), which included designated areas within the unincorporated area of Humboldt County and the cities of Arcata, Blue Lake, Eureka, Ferndale, Fortuna, Rio Dell and Trinidad, was established; and

**WHEREAS**, in 2002 the Humboldt County Board of Supervisors designated the Humboldt Waste Management Authority as the Zone Administrator for the Humboldt RMDZ; and

WHEREAS, in 2003 the Humboldt RMDZ was expanded to include Del Norte County and the City of Crescent City, and re-named the North Coast Recycling Market Development Zone ("North Coast RMDZ"); and

WHEREAS, the North Coast RMDZ is dedicated to establishing, sustaining and expanding recycling-based manufacturing businesses, which is essential for market development and meeting the landfill waste reduction goals established by the State of California; and

**WHEREAS**, California Public Resources Code Section 42011 requires the appropriate legislative bodies to renew RMDZs every ten (10) years; and

**WHEREAS**, the County of Humboldt still desires existing and new recycling-based manufacturing businesses located within the North Coast RMDZ to be eligible for the technical and financial incentives associated with the State of California's RMDZ program; and

WHEREAS, the renewal of the North Coast RMDZ is still necessary to facilitate local and regional recycling market development planning and coordination, support existing recycling-based manufacturing businesses and attract private sector recycling investments to the RMDZ; and

**WHEREAS**, the current and proposed waste management practices and conditions are favorable to the development of post-consumer and secondary waste materials markets; and

WHEREAS, the continued development of local markets for recycled materials will reduce the need to transport such materials out of the north coast region in the future; and

WHEREAS, local governing bodies may receive RMDZ program related payments as authorized by the California Public Resources Code; and

WHEREAS, the California Legislature has defined environmental justice as "the fair treatment of people of all races, cultures, and incomes with respect to the development, adoption, implementation, and enforcement of environmental laws, regulations, and policies" [Government Code section 65040.12 (e)], and has directed the California Environmental Protection Agency to conduct its programs, policies and activities that substantially affect human health or the environment in a manner that ensures the fair treatment of all races, cultures and income levels, including, without limitation, minority populations and low-income populations of the state [Public Resource Code section 7110(a)]; and

WHEREAS, CalRecycle has adopted a goal to continuously integrate environmental justice concerns into all of its programs and activities; and

WHEREAS, the County of Humboldt, the County of Del Norte and the cities of Arcata, Blue Lake, Eureka, Ferndale, Fortuna, Rio Dell, Trinidad and Crescent City have agreed to submit an application to CalRecycle requesting renewal of the North Coast RMDZ; and

WHEREAS, the County of Humboldt has agreed to act as Lead Agency for the proposed renewal of the RMDZ; and

**WHEREAS**, the Humboldt County Administrative Office has submitted evidence establishing that renewal of the North Coast RMDZ is categorically exempt from environmental review pursuant to Sections 15307 and 15308 of the California Environmental Quality Act ("CEQA") Guidelines.

**NOW, THEREFORE, BE IT RESOLVED**, by the Humboldt County Board of Supervisors, based on the evidence presented, and after considering the recommendation of the Humboldt County Administrative Office, that the Board:

- 1. Finds that renewal of the North Coast RMDZ is categorically exempt from environmental review pursuant to Sections 15307 and 15308 of the CEQA Guidelines; and
- 2. Approves renewal of the North Coast RMDZ and directs the Humboldt County Administrative Officer to submit an application to CalRecycle requesting renewal of the North Coast RMDZ which includes the County of Humboldt, the County of Del Norte and the cities of Arcata, Blue Lake, Eureka, Ferndale, Fortuna, Rio Dell, Trinidad and Crescent City; and
- 3. Approves receipt of any Recycling Market Development Zone related payments authorized by the California Public Resources Code, and authorizes the Humboldt County Administrative Officer, or designee, to execute in the name of County of Humboldt all documents necessary to secure payment and implement the associated activities.

BE IT FURTHER RESOLVED, by the Humboldt County Board of Supervisors that:

- 1. The Humboldt County Administrative Office is hereby directed to prepare, file and post a Notice of Exemption pursuant to Section 15062 of the CEQA Guidelines; and
- 2. The Humboldt Waste Management Authority is hereby authorized to continue administering the North Coast RMDZ in a manner that seeks to ensure the fair treatment of people of all races, cultures and incomes, including, but not limited to soliciting public participation in all communities within the North Coast RMDZ; and
- 3. The Executive Director of the Humboldt Waste Management Authority is hereby authorized to execute in the name of the North Coast RMDZ all documents necessary to secure RMDZ related payments authorized by the California Public Resources Code and implement any activities associated therewith.
