RE: Mid-Year Budget Review Department Reorganization

Dear County Supervisors:

This communication is to forward my thoughts and concerns regarding a potential reorganization/merger affecting the County Planning and Building Department.

I am not in favor of merging various Departments, or Divisions within Departments, to achieve a consolidation of services as it relates to the permitting and development process. The reasons for my being unsupportive of this concept are grounded in my 28 years of public service in local Planning Departments.

I believe the Department Head of a Planning and Building Department must have expertise in those focused fields, allowing for this position to be accessible on a daily basis. Such accessibility is crucial in order to render interpretations on County Code provisions. These interpretations and decisions must be immediate if we are to provide timely customer services. Expecting a Department Head to be proficient in the disciplines of Planning, Building, Environmental Health, Public Works Real Property Services, Roads, Parks, or other development related disciplines in order to make immediate decisions of applicability or legislative intent is misguided.

Having drafted a fair number of ordinances that have been adopted into the County Code, room was always built into ordinance language to allow for interpretation to address unique situations. It is impossible to envision every conceivable variation in the development process, and draft an ordinance that addresses every possible eventuality. Instead, it should fall to the Planning Director to evaluate a unique issue in the context of legislative intent, and allow permit applications to proceed in a timely manner. Each Department involved in the development review process has a specific mission, lead by a Department Head intimate with how individual Departmental policies fold into the overall development process.

We currently have a Planning and Building Department that has been transformed from the permitting nightmare spawned by a previous director into one much more responsive to customer service. The current Department was downsized from the cumbersome Community Development Services Department, and its mission has become more focused for staff and the public, resulting in overall improvements.

It would be wrong to merge and reorganize various Departments, or Divisions, with differing missions and policies solely to save an applicant a trip across town to meet with other Departments.

I support the current structure, culture, and administration of the Planning and Building Department, and attempting to create another Super Department for ill-conceived budget "savings" will result in unanticipated delays and inefficiencies.
