DISCUSSION:

Pursuant to Humboldt County Code ("HCC") Section 314-55.2.8.9, the Clerk of the Humboldt County Board of Supervisors ("Clerk of the Board") is required to mail the enforcing officer's accounting of the cost of the abatement of the nuisance caused by a violation of the Humboldt County's small parcel, personal use, medical marijuana ordinance to the owner of the parcel and to schedule a cost recovery hearing before the Humboldt County Board of Supervisors ("Board") no less than five days after the mailing to allow the owner to contest the accounting. At the request of the Clerk of the Board, the Code Enforcement Unit ("CEU") is bringing this matter before your Board to hear and consider confirming the accounting and proposed assessment, together with any objections and protests, of the abatement ordered by your Board on July 28, 2015, for the property known as 31 Heather Court, Whitethorn, California; AP# 109-251-009 ("Premises"). The abatement has been completed and the property owner has been served with a Cost Recovery Accounting of the charges incurred by the County of Humboldt ("County") in completing the abatement of the nuisance on the subject property as required by HCC 314-55.2.8.9.

The of Clerk the Board brought this matter before your Board on July 28, 2015, as an appeal of the CEU's determination of a violation of the County's small parcel, personal use, medical marijuana ordinance and an order to abate unlawful marijuana cultivation occurring on the Premises. After receiving written and oral testimony, your Board found that the conditions on the property were a public nuisance and ordered the owner to abate the violations within fourteen (14) days. The owner and the occupants did not notify the Code Enforcement Unit that the abatement had been completed. On August 22, 2015, the CEU served an abatement warrant at the Premises and determined that the abatement of the nuisance had been completed by the property owner. As required by HCC Section 314-55.2.8.8, the CEU maintained an accounting of the costs of the abatement and that sum is nine hundred fifty-one dollars and seven cents (\$951.07). The costs of the CEU's staff time, mileage and office costs are further broken down in the Cost Recovery Accounting, which is attached as Exhibit 1. The costs for driving time and mileage were reduced by a factor of four as the enforcing officer was inspecting numerous other parcels in the Whitethorn/Shelter Cove area during each of the inspections of the Premises.

The total proposed accounting and assessment is nine hundred fifty-one dollars and seven cents (\$951.07). We respectfully ask that your Board adopt the attached resolution declaring a special assessment against the Premises for the entire amount.

FINANCIAL IMPACT:

If the proposed accounting and assessment is denied or reduced by your Board, the County must absorb the cost of abatement up to the total of \$951.07. The assessment will support the Board of Supervisors' Core Roles of enforcing laws and regulations to protect residents and creating opportunities for improved safety and health.

RESOLUTION TO DECLARE AN UNPAID COST RECOVERY ACCOUNTING A SPECIAL ASSESSMENT AGAINST THE REAL PROPERTY OWNED BY ALEX POULOS (APN 109-251-009) PURSUANT TO HCC SECTION 314-55.2.8.10.4

WHEREAS, Government Code Section 25845 authorizes the County of Humboldt ("County") to enact an procedures for the abatement of public nuisances; and

WHEREAS, pursuant to this authority the County enacted Sections 314-55.2, *et seq.*, of the Humboldt County Code which establish processes for the abatement of nuisances generated by the cultivation of medicinal marijuana on small parcels and the recovery of the costs associated with such abatements; and

WHEREAS, on July 8, 2015, the Humboldt County Code Enforcement Unit ("Code Enforcement Unit") served an inspection warrant on the property located at 31 Heather Court in Whitethorn, California ("Premises"); and

WHEREAS, during the inspection of the Premises the Code Enforcement Unit found numerous marijuana plants being cultivated in the area served by the Shelter Cove Resort Improvement District in violation of Humboldt County Code Section 314-55.2.7.3; and

WHEREAS, pursuant to Humboldt County Code Section 314-55.2.8.3, the Code Enforcement Unit served the owner of the property, Alex Poulos ("Owner"), with a Notice and Order to Abate Unlawful Marijuana Cultivation on July 9, 2015, by sending the Owner a copy of the notice via certified mail and by posting two additional copies on the Premises; and

WHEREAS, the Notice and Order to Abate Unlawful Marijuana Cultivation advised the Owner that an appeal of the Code Enforcement Unit's determination must be filed within ten (10) days of the date the notice was served and that if an appeal was not requested the nuisance must be abated within fourteen (14) days; and

WHEREAS, the Owner requested a hearing on July 22, 2015, and the Clerk of the Humboldt County Board of Supervisors scheduled said hearing for July 28, 2015; and

WHEREAS, after considering all of the evidence presented at said hearing, the Humboldt County Board of Supervisors ("Board") upheld the Code Enforcement Unit's determination and ordered that the nuisance be abated within fourteen (14) days of their ruling; and

WHEREAS, the Code Enforcement Unit did not receive any evidence, either visual or verbal, from the Owner that the nuisance had been abated and consequently applied for and obtained an abatement warrant per Humboldt County Code Section 314-55.2.8.7.1; and

WHEREAS, on August 12, 2015, the Code Enforcement Unit served the abatement warrant at the Premises and determined that the nuisance had been abated by the Owner; and

WHEREAS, Humboldt County Code Section 314-55.2.8.8 requires that the Enforcing Officer keep an account of the cost of each and every abatement of the nuisance created by the cultivation of medicinal marijuana on small parcels; and

WHEREAS, the Enforcing Officer conducted such an accounting and determined that the cost to abate the nuisance created by the cultivation of medicinal marijuana at the Premises was \$951.07; and

WHEREAS, Humboldt County Code Section 314-55.2.8.9 requires the Clerk of the Board of Supervisors to mail the Enforcing Officer's accounting of the cost of abatement to the owner and to schedule a cost recovery hearing before the Board no less than five (5) days after the date of mailing, to allow the Owner to contest the accounting unless the amount is paid prior to the hearing date; and

WHEREAS, a cost recovery hearing was held on June 14, 2016 and the Board of Supervisors confirmed the Code Enforcement Unit's cost recovery accounting; and

WHEREAS, the amount of the unpaid cost recovery accounting as provided by Humboldt County Code Section 314-55.2.8.10.4 may be declared a special assessment against any real property owned by Owner within the County of Humboldt upon the Board's adoption of a resolution to declare a special assessment; and

WHEREAS, upon the adoption of a resolution to declare a special assessment, a Notice of Special Assessment Lien shall be recorded with the Humboldt County Recorder's Office; and

WHEREAS, upon recordation of the Notice of Special Assessment Lien, such lien may be collected at the same time and in the same manner as ordinary taxes are collected and shall be subject to the same penalties and the same procedure and sale in the case of delinquency as are provided for ordinary property taxes.

NOW THEREFORE BE IT RESOLVED:

1. The unpaid cost recovery accounting, in the amount of Nine Hundred Fifty-One Dollars and Seven Cents (\$951.07), shall be assessed as a special assessment against the following parcel number: 109-251-009.

- A Notice of Special Assessment Lien shall be recorded with the Humboldt County Recorder's Office.
