

Subject: Traffic Impact Fees

<u>RECOMMENDATION(S)</u>: That the Board of Supervisors discuss Traffic Impact Fees, give direction to Planning staff as it relates to agendizing a discussion of Traffic Impact Fees on the Planning Commission Agenda, and take appropriate action, as necessary.

<u>DISCUSSION</u>: On May 24, 2016, the Board to action to send a letter (the final letter was approved at the June 14, 2016 Board of Supervisors Meeting) to the Planning Commission clarifying the functions of the Planning Commission and outlining a process by which the Planning Commission could perform other functions as directed by the Board of Supervisors. As part of that process, and to properly adhere to the Government Code and provide transparency to the public, the Board requested that agenda items outside the scope of the statue be approved by the Board of Supervisors before placing said item on the Planning Commission agenda.

Supervisor Bohn has received a request from Planning Commissioner Alan Bongio for the Board to have a discussion related to Traffic Impact Fees, and following action by the Board, direct Planning staff to agendize Traffic Impact Fees on the next Planning Commission Agenda.
