DISCUSSION:

The Department of Health and Human Services (DHHS) – Public Health – Maternal, Child and Adolescent Health Division (MCAH) has been administering the Child Health and Disability Prevention (CHDP) and California Children's Services (CCS) programs locally since 1980.

CHDP is a preventive program that delivers periodic health assessments and services to low income children and youth in California. CHDP provides care coordination to assist families with medical appointment scheduling, transportation, and access to diagnostic and treatment services. Health assessments are provided by enrolled private physicians, community clinics, managed care plans and some local school districts.

CCS is a statewide program that authorizes diagnosis and treatment for financially eligible children with certain physical limitations and chronic health conditions or diseases. In addition, CCS authorizes the purchase of specific medical services and equipment, and provides physical and occupational therapy through the Medical Therapy Program. These services are provided at the Medical Therapy Unit located at the Glen Paul School site in Eureka.

The State Department of Health Care Services – Children's Medical Services Branch (CMS) requires an annual application process for the provision of CHDP and CCS services to Humboldt County with certification by the Board of Supervisors. By signing these two Certification Statements, Humboldt County certifies that the CHDP and CCS programs will comply with the CMS Plan and Fiscal Guidelines for fiscal year 2016-17. The recommendations before your Board today will allow CHDP and CCS to continue to provide these services to the community and receive quarterly reimbursement.

FINANCIAL IMPACT:

The CHDP and CCS programs are funded by CMS each year through a combination of federal and state funds. The approved county budget for the CHDP program residing in fund 1175, budget unit 418 has sufficient appropriations to cover the total allocation of \$428,003 for fiscal year 2016-17. The approved county budget for the CCS program residing in fund 1175, budget unit 493 also has sufficient appropriations to cover the total allocation of \$840,218 for fiscal year 2016-17. Approval of the Certification Statements and submission of the CMS packet will enable reimbursement for CHDP and CCS services. There is no impact to the county General Fund.

The recommendation before your Board supports the county's strategic framework by providing services to vulnerable populations.

OTHER AGENCY INVOLVEMENT:

The CMS Branch of the State Department of Health Care Cervices funds the CHDP and CCS programs.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could choose not to sign the Certification Statements. However, this would result in program elimination as Board certification is required to complete the CMS annual services plan and receive quarterly reimbursement for services provided.

Certification by the Board of Supervisors that the Child Health Disability Prevention and California Children's Services programs for Fiscal Year 2016-2017 are in compliance with applicable rules and regulations as specified in the attached certification statements.

What is the main purpose of this agenda item?

To request the Board to certify compliance with the CMS program for FY 2016-2017 by signing the certification statements per state requirements.

Program Title:

The Children's Medical Services Program (CMS) includes Child Health and Disability Prevention (CHDP) and California Children's Services (CCS).

Program Highlights:

CCS authorizes diagnostic and treatment services, provides medical case management, and provides physical and occupational therapy services to children under age 21 with CCS-eligible medical conditions, including chronic medical conditions such as cystic fibrosis, hemophilia, cerebral palsy, heart disease, cancer, traumatic injuries, and infectious diseases. CCS medical therapy services are delivered at the Glen Paul school site.

CHDP is a health promotion and disease prevention program serving California's infants, children and teens. CHDP uses state and federal funds to reimburse enrolled health care providers for delivering health assessments and preventive health services to CHDP eligible children. CHDP services are provided free of charge to eligible children. The program helps to link children to needed resources and health care coverage.

How long has this program been in effect?

CCS has been in existence since 1927. CHDP has been in existence since 1947. These are long-standing programs.

Is it a state mandated program?

Yes, CMS is a state mandated program. CCS is mandated by the California Welfare and Institutions Code and by the California Code of Regulations, Title 22, Section 51013. The enabling statute for the CCS program is Health and Safety Code, Section 123800.

CHDP is granted authority by the Health and Services code Sections 104395, 105300, 105305, 120475, and 124025 through 124110; the California Code of Regulations (CCR) Title 17, Sections 6800 through 6874; and the CCR, Title 22, Sections 51340 and 51532.

Is this program part of a larger program?

CHDP and CCS are part of Children's Medical Services (CMS), which resides within the California Department of Health Care Services.

Is this a subcontract? If yes, why?

No subcontracts are involved in this agenda item.

Items of interest: (primary funding, program mission etc.)

Beginning with Fiscal Year 2006-07, the CMS Branch requires counties to submit two separately signed Certification Statements, one for CHDP and another for CCS. The Certification Statements are valid for one year. Approval of the Certification Statements by the Board of Supervisors is necessary to complete the annual plan and budget for FY 2016-117.
