

Subject: Adjust Humboldt County Library (HCL) Hours of Operation for November 23, 2016; December 24, 2016, and December 31, 2016 at all HCL locations.

## RECOMMENDATION(S):

That the Board of Supervisors approves the change in open hours for the HCL as specified on Attachment 1 to accommodate an early closure of the County Library on November 23, 2016 and closure December 24 and December 31, 2016.

## SOURCE OF FUNDING:

## DISCUSSION:

Traditionally, the Humboldt County Library receives little business on a day before an official holiday, and in anticipation of the coming holidays in 2016 the County Library requests that the Board of Supervisors approve an early closure of the County Library on the evening prior to the Thanksgiving holiday, November 23, 2016. Many of the branches currently have evening hours on Wednesdays and the proposed schedule would close all branches at 5:00 PM on Wednesday November 23, 2016. This proposal seeks to shift the open hours on the Wednesday immediately prior to the listed Thursday holiday by eliminating the current Wednesday evening hours. The Prepared by W. Love CAO Approval

proposed adjustment will shift public open hours to earlier in the day to allow County Library staff members to have the evening hours of the day before this holiday off.

Additionally, it is requested to close on the day prior to the Christmas holiday, December 25, 2016 and the New Year's Day holiday, January 1, 2017 which occur on Sundays. The current County holiday schedule calls for a Monday holiday for these holidays. Traditionally, the County Library is permitted to close on the prior Saturday to Sunday holidays in order to allow the staff a three day weekend because the Library is normally closed on Mondays.

#### FINANCIAL IMPACT:

To provide community appropriate levels of service.

Approval of the shift in open hours would not increase costs nor decrease costs for the Library.
