The Department of Health and Human Services (DHHS) has requested and been approved by Merit System Services (MSS) to allocate a Social Worker Supervisor I position in In Home Supportive Services (IHSS). An agenda item is in development to request your Board's approval to disallocate vacant positions and allocate this position and other MSS recommendations within IHSS. assumed the principle duties of the Social Worker Supervisor I in accordance with Section 12.4.1 of the AFSCME Memorandum of Understanding for a total of 20 consecutive work days; which ends November 19, 2016. The Department of Health and Human Services is requesting that the Board of Supervisors approve continuance of the acting supervisor salary until the position is filled.

FINANCIAL IMPACT:

The increased monthly cost of a Social Worker Supervisor I (Class 1708, Range 445) from a Social Worker III (Class 0727C, Range 392) is \$1,209. Approval of the continuance of the acting supervisor until the position is filled, starting effective November 19, 2016, is estimated at \$9,068 for the remainder of the 2016-17 fiscal year. This position resides in fund 1160, budget unit 511 (Social Services) and is funded through IHSS. There is sufficient appropriation to cover this request due to unexpected salary savings. There is no impact to the county general fund.

Approving this recommendation will support the Board's Strategic Framework by providing and maintaining infrastructure and by creating opportunities for improved safety and health.

This letter is in response to your department's request to add additional IHSS positions in response to the Quality Improvement Action Plan initiated by the California Department of Social Services (CDSS) and additional positions assigned to Adult Protective Services to meet workload needs.

IHSS POSITIONS

Social Worker Supervisor I (1)

- Plans, assigns, directs, mentors, coaches and reviews the work of SW I/II and SW III staff.
- Selects, trains, evaluates, and disciplines subordinate staff.

Social Worker III (2)

 IHSS case assignments including, IHSS intake assessment, complex case management, case planning, safety planning, and linkages to community supports.

Social Worker I/II (2)

 IHSS case assignments including, IHSS ongoing assessment, case planning, safety planning, and linkages to community supports.

APS POSITIONS

Social Service Aide

 Provide case support to SW III and IV providing APS Services. Including assistance with transportation, housing and accessing community resources.

Social Worker IV

 APS case assignment including immediate response, investigation and assessment of abuse and neglect, ongoing case planning and management, intervention and linkages to community supports.



Based on the duties that have been identified and the program needs, these positions are the appropriate classifications for these duties

Once your department has approval from the Board of Supervisors to add these positions, please provide MSS with the Board minutes. Once received, MSS will conduct recruitments to fill these vacancies, at the county's request.
