DISCUSSION:

Humboldt County Probation until recently utilized a polygraph vendor for the completion of all background checks for incoming sworn staff during the hiring process. Unfortunately, the vendor was not local and when the company lost another contract, stopped traveling regularly to Humboldt County. It was not cost-effective to send all sworn applicants out of the area for polygraph so Humboldt County Probation began researching alternative options and came upon compelling information regarding Computer Voice Stress Analysis (CVSA). CVSA technology records, quantifies and analyzes frequency changes in the human voice. During the examination the equipment identifies vocal stress related to specific questions. The identification of this vocal stress can be directly correlated to truth and deception. CVSA has a remarkably low error rate (less than 0.5%) and does not return inconclusive results. It is widely accepted to be more reliable than polygraphs.

The Humboldt County Sheriff's Office (HCSO) utilizes CVSA not only for their own background investigations but also in the course of investigative police work. Humboldt County Probation began contracting with HCSO in July to provide this service during background investigations. While the process worked well, due to the Sheriff's own demand on the equipment getting Probation applicants scheduled for CVSA appointments can be difficult. The cost of contracting for these CVSAs is also more than double the cost previously paid for polygraph services (\$125.00/polygraph vs. \$257.37 per CVSA). In order to offset the high cost of contracting these services going forward and to improve hiring turnaround time, Probation would like to invest in a CVSA notebook and training for select management staff to conduct these analysis interviews with applicants. The streamlining of the hiring and background process will mean shorter vacancies for Juvenile Corrections Officer and Probation Officer positions which aids your Board's strategic framework goal of creating opportunities for improved safety and health.

FINANCIAL IMPACT:

The total cost of the notebook with digitized CVSA technology is \$9053 which comes with a four year Dell warranty and two complimentary new examiner training slots which can be utilized to certify staff anytime within the first year of purchase. In addition, Probation will be purchasing three more discounted new examiner student tuitions at \$495 each. These can be used to certify new examiners or re-certify existing examiners (required every two years) and have been discounted from \$1295. The total initial cost of this project is estimated to be \$10, 538. The funds will come from Probation trust funds and be expended in the 2016/17 fiscal year. There is no ongoing cost in years where examiners do not require re-certification and in years that do require recertification, the cost will be \$3885, or \$1295 for each examiner (every 2 years). The funds for the initial cost to purchase the notebook and student tuitions for three new examiners will come from the Probation trust fund 3782-000-808000 which has a current balance of \$790,998. Recertification costs will be included in the budget in future years.

Probation contracted for a total of 26 polygraphs in 2015/16 which at the current Sheriff CVSA rate would translate to an approximate annual cost of \$6691.62. The initial cost of purchasing this equipment and training Probation management staff to conduct these examinations would directly offset this cost and being resulting in budgetary savings in approximately 18 months. This purchase meets the Board's Strategic Framework goal of managing resources to ensure sustainability of services.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board may opt not to approve the attached supplemental budget for this purchase however it is not recommended. Without the purchase of this equipment and the corresponding staff training Humboldt County Probation will continue to contract these services out to the Sheriff at an increased cost and adding increased length to the already lengthy process of hiring sworn officers.
