DISCUSSION:

On January 19, 2016, your Board approved the first stage in a comprehensive finance package to move the county in the direction of having campuses where like functions are grouped together for better public service.

The Public Defender building is a key component in the finance package, campus concept. The property next door to the Public Defender building, 1017 4th Street, Eureka, and its adjacent block are for sale. Should the county purchase 1017 4th Street and the adjacent block it would provide significant benefits to

FINANCIAL IMPACT:

Included in the January 19, 2016, agenda item your Board directed the Treasurer Tax Collector and County Administrative Office to secure \$5,590,000 for various capital improvement projects. Architectural Engineering service for design of a new building at 1001 4th Street (Public Defender Building) was part of this financing package. Potentially a portion of this funding could be used to purchase this property.

The current action has no financial impact. Should a purchase be negotiated staff will return to your Board and may present alternative funding options at that time.
