- 3. Reappoint Brian Anderson as the Fire Chief's Association representative;
- 4. Reappoint Ginger Campbell, as the District 3 representative; and
- 5. Appoint a District 5 representative to fill the remaining term of Helen Edwards.

DISCUSSION: On January 20, 2017, the two At Large seats currently held by Lora Canzoneri and Adam Jager on the Measure Z Citizens' Advisory Committee expired. In addition, the Fire Chief's Association representative seat currently held by Brian Anderson, and the District 3 Representative seat currently held by Ginger Campbell expired on January 20, 2017 as well. District 5 representative Helen Edward's term expires on January 20, 2019. However, she has left the area and has resigned her position on the Measure Z Citizens' Advisory Committee.

The Fire Chief's Association is recommending the reappointment of Brian Anderson and 3rd District Supervisor Mike Wilson is recommending the reappointment of Ginger Campbell. 

I am now familiar with the county budget, know how to read budget materials and to decipher costs, request, debits, etc. This committee evaluates the needs of all public safety departments and agencies that are eligible to receive this money, and I am able to understand budget requests and prioritize needs and make reasonable recommendations.

I am interested in continuing to serve on the Citizens' Advisory Committee on Measure Z Expenditures. I am passionate about public safety and am interested in seeing that the desires of the citizens who voted on this measure are well represented. I have been a volunteer with the Arcata Police Department for eight years, fundraising in order to acquire and maintain our three K9s. I also have helped establish and maintain 29 successful current (and growing) Neighborhood Watch Programs in Arcata. By invitation of the Sheriff, I have helped to build and establish NWPs with Trinidad and Blue Lake, their contracted cities as well as, spearheading NW programs in 31 other county locations. There is now an established Business Watch in McKinleyville, Willow Creek and Trinidad. I helped with the fundraising efforts to purchase Ella, one of the Eureka PD K9's and the same for Maggie the drug dog. I worked with Fortuna Police to help raise funds to keep Zorro when he was still with us and on duty.

I volunteer about 25-30 hours per week in law enforcement projects, and have an ear to the ground on what the public wants, what they are hoping for with the Measure Z monies, and feel I have a voice to bring to the table as we evaluate the needs of all of the public safety departments.

As former Chairmen of the Hoopa Valley Tribe, I have overseen a five million dollar budget annually and worked with twenty five independent departments budgets. I am familiar with procurement process for assisting with securing tribal funding through collaboration within six tribal departments for annual Consolidated Tribal Assistance Solicitation (CTAS). Tribal Police have been successful in securing funds for hiring, equipment and training for the past few years.

I have worked effectively with the county on bringing law enforcement to the Hoopa Valley Reservation with collaboration of Cross Deputization agreements and working with the county to secure adequate ambulance services funding. I have cultural knowledge of families and people in the community throughout both reservations.

I feel I can bring some much needed knowledge and service to the board with my experience of working in the outlying areas of the Hoopa Valley and Yurok Tribal reservations. We have a great need for services in both of these rural areas that still lack electricity, phone and internet services. We are also in need of adequate fire and law enforcement availability in these areas.
