We wish you success in your future endeavors.

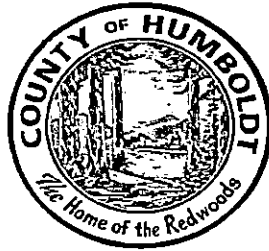
