<u>DISCUSSION</u>: The Clerk of the Board is requesting the Board of Supervisors set a date to make an appointment to fill an At-Large vacancy on the Humboldt County Aviation Advisory Committee (Per Board Appointments Protocol dated April 19, 2011). The vacancy is the result of the expired term of At-Large member David Ravetti.

Mr. Ravetti was appointed to the Aviation Advisory Committee as an At-Large member on August 21, 2012 to fill the remaining term of Gregg Foster, whose term expired June 30, 2013. Due to an oversight in the Clerk of the Board's office, Mr. Ravetti's appointment on August 21, 2012 was incorrectly listed on the Aviation Advisory Committee roster as a four-year term, expiring on June 30, 2016. However, Aviation Advisory Committee members serve at the pleasure of the Board, and Mr. Ravetti has been serving in that capacity since June 30, 2013.

The Clerk of the Board's office has posted the vacancy and is accepting applications until a future agenda date is set. Also, please note that Mr. Ravetti has requested to be reappointed to fill the At-Large vacancy on the Aviation Advisory Committee.
