Subject: Informational Report on the Appointment of Kenny Priest to the Fish and Game Advisory Commission Representing District 4

<u>DISCUSSION</u>: Kenny Priest was appointed to a four-year term on the Humboldt County Fish & Game Advisory Commission on June 23, 2015, representing District 3, and has been serving admirably since that time. Supervisor Wilson is requesting that Mr. Priest be reassigned to District 4 where he currently lives.

District 4 currently has a vacancy, and Supervisor Bass is announcing her appointment of Kenny Priest to the Humboldt County Fish & Game Advisory Commission to a new three-year term, expiring on June 30, 2020, representing District 4.

Note: this appointment will fill the last vacancy in District 4 on the Fish & Game Advisory Commission, and create a second vacancy in District 3 on the Commission.
