Subject: Informational Report on the Appointment of Kenny Priest to the Fish and Game Advisory Commission Representing District 4

DISCUSSION: Kenny Priest was appointed to a four-year term on the Humboldt County Fish & Game Advisory Commission on June 23, 2015, representing District 3, and has been serving admirably since that time. Supervisor Wilson is requesting that Mr. Priest be reassigned to District 4 where he currently lives.

District 4 currently has a vacancy, and Supervisor Bass is announcing her appointment of Kenny Priest to the Humboldt County Fish & Game Advisory Commission to a new three-year term, expiring on June 30, 2020, representing District 4.

**Note: this appointment will fill the last vacancy in District 4 on the Fish & Game Advisory Commission, and create a second vacancy in District 3 on the Commission.**



## FISH AND GAME ADVISORY COMMISSION

**AUTHORITY:** Formed July 10, 1956, by Board Order, and reorganized by Board Order on June 3, 1964; Ordinances 682, 1660, 1665, and 2050

**APPOINTING POWER:** Board of Supervisors

**MEMBERS:** Fifteen (15) – The Supervisor of each District shall appoint three (3) members (not required to live in District). Serve at POB. The BOS *may* appoint up to five (5) associate non-voting members that serve at the pleasure of the Board.

**QUALIFICATIONS:** Interest in County issues regarding fishing and game hunting

**TERM:** Terms Expire on June 30<sup>th</sup> - Four (4) Year Staggered Terms (Dist 1, 2, 3 and Dist 4, 5 expire 3 years apart)

**FUNCTION:** Established to serve in an advisory capacity to the Board of Supervisors in all matters concerning fish and wildlife within the County of Humboldt.
