<u>DISCUSSION</u>: Harry Vaughn was appointed on January 12, 1999 and reappointed on July 25, 2006 and December 07, 2010 to serve on the Humboldt County Fish & Game Advisory Commission, representing District 3, and has been serving admirably since that time. Supervisor Wilson is requesting that Mr. Vaughn be reassigned to District 2 where he currently lives.

District 2 currently has a vacancy, and Supervisor Fennell is announcing her appointment of Harry Vaughn to the Humboldt County Fish & Game Advisory Commission to a new four-year term, expiring on June 30, 2021, representing District 2.

Note: this appointment will fill the last vacancy in District 2 on the Fish & Game Advisory Commission, and create a third vacancy in District 3 on the Commission.
