RECOMMENDATION(S):

That the Board of Supervisors:

- 1. Introduce the attached ordinance by title and waive the first reading;
- 2. Set the ordinance for adoption on April 4, 2017, or at least one week away;
- 3. Direct the Clerk of the Board of Supervisors to publish the pre-adoption summary of the ordinance and to post a certified copy of the full text of the proposed ordinance in the office of the Clerk of the Board of Supervisors at least five (5) days prior to the Board of Supervisors meeting at which the ordinance will be adopted [Government Code Section 25124(b)(1)];
- 4. Direct the Clerk of the Board, within fifteen (15) days after adoption of the ordinance, to publish a post-adoption summary of the ordinance with the names of the Supervisors voting for and against the ordinance and to post in the office of the Clerk of the Board of Supervisors a certified copy of the full text of the adopted ordinance along with the names of those Supervisors voting for and against the Ordinance [Government Code Section 25124(b)(1)]; and
- 5. Direct Humboldt County Department of Public Works to file the attached Notice of Exemption with the Humboldt County Clerk in accordance with the California Environmental Quality Act.

DISCUSSION:

The proposed ordinance (Attachment 1) sets the speed limit on Holly Street in the Eureka area from the intersection of Walnut Drive to the intersection of Excelsior Road to thirty (30) miles per hour. It also prohibits parking along a portion of North Ridge Road from post mile 0.18 to post mile 0.41 and a portion of Pennsylvania Avenue from post mile 0.239 to post mile 0.240 in the Eureka area.

The residences on Holly Street in Eureka petitioned the Humboldt County Department of Public Works, requesting the installation of speed humps. For speed humps to be installed on a county maintained roadway a speed limit of thirty (30) miles per hour or below must exist. In reviewing the Humboldt County Code, there was no designated speed limit for Holly Street, so staff performed an engineering traffic survey ("ETS").

The Caltrans Traffic Manual states that "The speed limit normally should be established at the first five (5) mile per hour increment below the eighty-five (85) percentile speed. However, in matching existing conditions with the traffic safety needs of the community, engineering judgment may indicate the need for a further reduction of five (5) miles per hour."

The ETS recommendation for posting Holly Street from post mile 0.00 to post mile 0.20, eighty-five (85) percentile twenty-nine (29) miles per hour, is a posted speed of thirty (30) miles per hour.

The Humboldt County Department of Public Works – Division of Natural Resources requested a no parking zone on the east side of North Ridge Road within the property boundaries of the McKay Community Forest in the anticipation of developing a parking area and trail (see attached email). After multiple meetings with the North Ridge neighborhood group, a compromise was reached, that would lessen the impact of increased traffic to their neighborhood and lessen safety issues of more vehicles parking on the narrow roadway.

The request for a no parking zone on Pennsylvania Avenue came from Strombeck Properties and is based on conditions of approval, condition 2.5, from the Planning Commission for the Strombeck Subdivision Parcel Map (see attached conditions). The condition is based on a traffic safety.

The proposed ordinance is considered a project under the California Environmental Quality Act ("CEQA"). This project is categorically exempt from environmental review pursuant to Section 15301 – Existing Facilities and Section 15305 – Minor Alterations in Land Use Limitations of the CEQA Guidelines, and the application of this categorical exemption is not barred by one of the exceptions set forth in Section 15300.2 of the CEQA Guidelines. A Notice of Exemption is included in Attachment 2.

FINANCIAL IMPACT:

The cost for the manufacturing and installation of the regulatory signs are estimated at \$130.00 per sign and is covered in the Road Fund budget. There will be no impact to the General Fund.

The requested action conforms to the Board of Supervisors core roles of providing for and maintaining infrastructure and creating opportunities for improved safety.

OTHER AGENCY INVOLVEMENT:

California Highway Patrol enforces traffic laws on county roads.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could choose to not adopt the ordinance; however, this action is not recommended since doing so would not improve traffic safety in these locations.

Art,

Thank you for meeting at the North Ridge access location for the McKay Community Forest.

This access point and the corresponding parking area and trail development that will be completed is critical for our plans moving forward with public recreation in the McKay Community Forest (MCF). As we discussed, this is the only feasible public access point where a parking area and large trailhead can be established relatively quickly. There are no other locations that fit the requirements for access into the MCF, Harris Street is the only other location where the MCF abuts a public roadway, but creating a parking area here is not feasible. The location of the MCF is bounded largely by private property and thus arrangements for easements and access points will need to be worked out into the future.

In order to safely and effectively establish this parking and trailhead area, it is important for several reasons to implement a "No Parking" area along the north side of North Ridge Road. Most notably after multiple meetings with the North Ridge neighborhood group, it became apparent that in order to get acceptance from them of establishing a parking and trailhead area in their neighborhood, we would need to enforce a no parking zone across from their homes. In addition the road will be in close proximity to the trail alignments planned in this area, both multiple use trails, as well as the accessibility trails. Therefore we felt that there would be too great a temptation by the public to park along North Ridge Road and simply get onto the trails from non-established and non-approved access points. Finally, North Ridge Road is already a narrow neighborhood roadway, if vehicles park on the north side it becomes unsafe for travel by vehicles and especially dangerous for pedestrian mobility.

From a management standpoint we would like to focus the use to the planned parking and trailhead area that is located near the corner of Walnut Drive and North Ridge Road. This location has enough area for the required amount of parking spaces and is relatively flat. Entrance and exit from the planned parking area has good visibility and is a safer option for public access to the trail networks into the MCF.

b.5 **EXPIRATION OF TENTATIVE MAP:** Applicant is advised to contact the Planning & Building Department to determine the expiration date of the tentative map and what time extension(s), if any, are applicable to the project. Applicant is responsible for the timely filing of time extension requests to the Planning & Building Department.

Construction plans shall be tied into elevation datum approved by this Department.

Unless otherwise waived by this Department, record drawing ("As-Built") plans shall be submitted for any road, drainage, landscaping, and pedestrian improvements that are constructed as part of this project. Record drawing plans must be prepared by a Civil Engineer registered by the State of California. Once approved by this Department, one (1) set of "wet stamped" record drawings on 22" x 34" mylar sheets shall be filed with this Department.

- 2.2 **CONSTRUCTION PERIOD**: Construction of improvements for this project will not be allowed to occur between October 15 and April 15 without permission of this Department.
- 2.3 **ADA FACILITIES**: All pedestrian facilities shall be ADA compliant. This includes, but is not limited to, providing curb ramps at intersections and sidewalks behind driveway aprons (or ADA compliant driveway aprons).

Fire hydrants, neighborhood box units for mail, utility poles (including down guys), street lights, or other obstructions will not be allowed in sidewalks unless approved by this Department.

Applicant shall replace/retrofit to meet current standards any non-ADA compliant pedestrian improvements within the public right of way (or access easements that the subject property has a legal right to use) contiguous to the project.

The construction of curb ramps also requires the upgrade of non-ADA compliant companion curb ramps that may be off-site.

- 2.4 **TRAFFIC CONTROL DEVICES**: Street name and traffic control devices may need to be placed as required and approved by this Department.
- 2.5 **ACCESS ROADS**: The surface of the access road(s) shall conform to the *Structural Section* requirements within this document. The access road(s) serving the subdivision shall be constructed to the satisfaction of this Department as follows:
 - (a) PENNSYLVANIA AVENUE (COUNTY ROAD NO. 3K480): Applicant shall remove and replace any public curb, gutter, sidewalk, flowline drain, or pavement found by this Department to be broken, uplifted, or damaged that fronts or is within the subdivision.

The existing driveway apron on Parcel 1 shall be retrofitted for ADA compliance.

The applicant shall submit a written letter to the Road Maintenance Division of the Department of Public Works requesting the establishment of a no-parking zone along the Pennsylvania Avenue frontage of Parcel 1 near the intersection Quaker Street to improve visibility at the intersection.
