DISCUSSION: Officer Rich Schlesiger passed away on September 7, 2015 from a rare form of brain cancer. The loss of Corporal Schlesiger and his tremendous contributions to Humboldt County and law enforcement have deeply affected this community. In August 2016 the Board of Supervisors requested Assembly Member Wood and Senator Mike McGuire to draft a Joint Resolution to be proposed in both houses to designate an area on State Highway 101 in memory of Corporal Schlesiger. Assembly Member Wood introduced, and Senator McGuire co-authored, ACR 43 on March 23, 2017.
