# Impact Analysis District Consolidation from Odd-Year to Even-Year General Elections Blue Lake Union School District

#### **Summary**

On March 6, 2017, the Humboldt County Board of Supervisors received Resolution No. 2016/17-02 from the Blue Lake Union School District requesting the district election cycle be held in even-numbered years. Pursuant to Elections Code, Section 10404.5 (d)(1), the following is an impact analysis of the effects that may result due to the consolidation.

Blue Lake Union Elementary School District, which has approximately 1,635 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Because of significantly lower turnout by the voters, the district must change to even-numbered year elections no later than 2022 according to Elections Code, Section 14052. If the change is approved, Blue Lake Union Elementary School District will experience a savings in future even-numbered year elections.

#### Fiscal Impact, Districts

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

If Blue Lake Union School District switches to even-numbered election years and goes to election in the future, it would pay much less than if it remains in odd-numbered year elections and actually goes to the ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. When there is less sharing of voters or ballot types, costs increase to the remaining districts and at times, a district is responsible for the full cost of a ballot type. The likelihood of a district bearing the entire cost of a ballot type will increase for districts that remain in odd-numbered years.

### Fiscal Impact, County

As districts move from odd to even-year elections, there will be an overall cost increase including costs due to additional ballot types, a longer ballot, and the probability of a two page ballot. The size of the voter information guide will increase as will the costs for mailing the voter guide and vote-by-mail ballots. Additional staff and extra help hours will be expended for logic and accuracy testing, programming, and processing ballots. Though districts will continue to be billed for their share in election costs, theirs is a much smaller percentage of total costs. The County's actual costs are expected to increase.

Bridgeville Elementary School District, which has approximately 333 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Because of significantly lower turnout by the voters, the district must change to even-numbered year elections no later than 2022 according to Elections Code, Section 14052. If the change is approved, the district will experience a savings in future even-numbered year elections.

### Fiscal Impact, Districts

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

In the November 2013 Uniform District Election (UDEL), Bridgeville Elementary School District had three governing board member positions on the ballot. The cost per voting opportunity for the UDEL was \$.90, and the district was charged \$925. The average cost of the past 3 statewide general elections held in even numbered years is \$.25 per voting opportunity. Bridgeville Union Elementary School District would have paid approximately \$250 for the contest had it appeared on a statewide general election ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. When there is less sharing of voters or ballot types, costs increase to the remaining districts and at times, a

district is responsible for the full cost of a ballot type. The likelihood of a district bearing the entire cost of a ballot type will increase for districts that remain in odd-numbered years.



# Impact Analysis District Consolidation from Odd-Year to Even-Year General Elections Fieldbrook School District

#### **Summary**

On March 9, 2017, the Humboldt County Board of Supervisors received resolution number 0217 from the Fieldbrook School District requesting the district election cycle be held in evennumbered years. Pursuant to Elections Code, Section 10404.5 (d)(1), the following is an impact analysis of the effects that may result due to the consolidation.

Fieldbrook School District, which has approximately 671 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Because of significantly lower turnout by the voters in the district, Fieldbrook School District must change to even-numbered year elections no later than 2022 according to Elections Code, Section 14052. If the change is approved, the district will experience a savings in future even-numbered year elections.

#### Fiscal Impact, Districts

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

No past billing information was located for Fieldbrook School District. However, if Fieldbrook School District switches to even-numbered election years and goes to election in the future, it would most certainly pay much less than if it remains in odd-numbered year elections and actually goes to the ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. When there is less sharing of voters or ballot types, costs increase to the remaining districts and at times, a district is responsible for the full cost of a ballot type. The likelihood of a district bearing the entire cost of a ballot type will increase for districts that remain in odd-numbered years.

### Fiscal Impact, County

As districts move from odd to even-year elections, there will be an overall cost increase including costs due to additional ballot types, a longer ballot, and the probability of a two page ballot. The size of the voter information guide will increase as will the costs for mailing the voter guide and vote-by-mail ballots. Additional staff and extra help hours will be expended for logic and accuracy testing, programming, and processing ballots. Though districts will continue to be billed for their share in election costs, theirs is a much smaller percentage of total costs. The County's actual costs are expected to increase.

Elections Code, Section 15372, states the elections official shall prepare a certified statement of the results of the election and submit it to the governing body within 30 days of the election. Because governing board members of special and school districts would take office on the first Friday in December following the district general election, Elections Code, Section 10511(a), requires the elections official to declare the elected candidate or candidates no later than the Monday before the first Friday in December, which will shorten the canvass period for elections in even-numbered years from 30 days to 27 days. This would negatively impact the Office of Elections, especially in a Presidential Election year when all 30 days are needed to complete the canvass. Automated scanning and sorting equipment to assist staff with processing vote-bymail ballots would be required.

#### **Summary**

On March 3, 2017, the Humboldt County Board of Supervisors received Resolution No. 2016-2017.05 from the Fortuna Union High School District requesting the district election cycle be held in even-numbered years. Pursuant to Elections Code, Section 10404.5 (d)(1), the following is an impact analysis of the effects that may result due to the consolidation.

Fortuna Union High School District, which has approximately 12,350 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Because of significantly lower turnout by the voters, the district must change to even-numbered year elections no later than 2022 according to Elections Code, Section 14052. If the change is approved, the district will experience a savings in future even-numbered year elections.

#### **Fiscal Impact, Districts**

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

In the November 2015 Uniform District Election (UDEL), Fortuna Union High School District had two governing board member positions on the ballot. The cost per voting opportunity for the UDEL was \$1.43, and the district was charged \$33,650. The average cost of the past 3 statewide general elections held in even numbered years is \$.25 per voting opportunity. Fortuna Union High School District would have paid approximately \$6,200 for the contest had it appeared on a statewide general election ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. When there is less sharing of voters or ballot types, costs increase to the remaining districts and at times, a

district is responsible for the full cost of a ballot type. The likelihood of a district bearing the entire cost of a ballot type will increase for districts that remain in odd-numbered years.

### Fiscal Impact, County

As districts move from odd to even-year elections, there will be an overall cost increase including costs due to additional ballot types, a longer ballot, and the probability of a two page ballot. The size of the voter information guide will increase as will the costs for mailing the voter guide and vote-by-mail ballots. Additional staff and extra help hours will be expended for logic and accuracy testing, programming, and processing ballots. Though districts will continue to be billed for their share in election costs, theirs is a much smaller percentage of total costs. The County's actual costs are expected to increase.

# Impact Analysis District Consolidation from Odd-Year to Even-Year General Elections Hydesville School District

#### Summary

On January 25, 2017, the Humboldt County Board of Supervisors received resolution number 111716 from the Hydesville School District requesting the district election cycle be held in evennumbered years. Pursuant to Elections Code, Section 10404.5 (d)(1), the following is an impact analysis of the effects that may result due to the consolidation.

Hydesville School District, which has approximately 830 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Since there is no election to compare results, Hydesville School District does not fall below the threshold set forth in Elections Code § 14052, and it is not mandatory for it to switch to even-numbered years at this time. However, Election Code §1302(b), allows the governing body of a school district the ability to transition to evennumbered year elections regardless of whether it experiences decreased voter turnout or not. Therefore, any school district can move.

#### Fiscal Impact, Districts

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

No past billing information was located for Hydesville School District. However, if Hydesville School District switches to even-numbered election years and goes to election in the future, it would most certainly pay less than if it remains in odd-numbered year elections and actually goes to the ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. When there is less sharing of voters or ballot types, costs increase to the remaining districts and at times, a

district is responsible for the full cost of a ballot type. The likelihood of a district bearing the entire cost of a ballot type will increase for districts that remain in odd-numbered years.

WHEREAS, the current date for election of members of the Governing Board of Hydesville Elementary School District ("District") is every two (2) years on the first Tuesday after the first Monday in November of odd-numbered years (e.g. November 2017) (Education Code section 5000 and Elections Code section 1302 (a)); and

WHEREAS, statewide general elections are held in California only in June and November of even-numbered years (e.g., November 2016) (Elections Code section 1001); and

WHEREAS, the District is located within Humboldt County; and

WHEREAS, generally voter turnout is greater for statewide general elections than for local elections, including school board member elections held in November of odd-numbered years; and

WHEREAS, California Senate Bill 415, an act (which may be cited to as the California Voter Participation Rights Act (herein "the Act")) to add Chapter 1.7 (commencing with Section 14050) to Division 14 of the Elections Code, was approved by the California Governor and filed with the Secretary of State on September 1, 2015; and

WHEREAS, Commencing January 1, 2018, the Act prohibits a political subdivision from holding an election other than on a statewide election date (i.e. "off-cycle") if holding an election on a non-concurrent date has previously resulted in voter turnout for a regularly scheduled election in the political subdivision being at least 25% less than the average voter turnout within the political subdivision for the previous four statewide general elections; and

WHEREAS, a political subdivision may, however, hold an off-cycle election if, by January 1,2018, the political subdivision has adopted a plan to consolidate a future election with a statewide election not later than the November 8, 2022, statewide general election; and

WHEREAS, The Act authorizes attorney's fees to a prevailing plaintiff who has appropriately filed an action in superior court to enforce the Act's prohibition; and

WHEREAS, the District may achieve a savings in the cost of its elections, if the District's elections are consolidated with the statewide general elections; and

WHEREAS, as a result of these facts, the Board desires to change the date of future board member elections to be consolidated with the California statewide general election in order to save public funds and provide greater voter input into school board elections; and

WHEREAS, Elections Code 1302(b) establishes a procedure whereby the Governing Board may change the election date for its board members by adopting a resolution seeking approval of the change by the Board of Supervisors of the affected county (Elections Code section 10404.5); and

WHEREAS, if the change in election date is approved, it is requested that the new election date be moved from the first Tuesday after the first Monday in November 2017 to the first Tuesday after the first Monday in November 2018 with board members whose terms would have expired in 2017 being extended to 2018 and board members whose terms would have expired in 2019 being extended to 2020 [ refer to Appendix A].

NOW, THEREFORE, BEIT RESOLVED that the Governing Board hereby finds, determines and/or declares, as follows:

- 1. Each of the foregoing is true and correct.
- 2. The Governing Board declares its intent to adopt this resolution to consolidate the election date for members of the Board with the date for the California general election in November in even-numbered years (Elections Code section 1001) pursuant to Elections Code section 1302(b).
- 3. The Superintendent will forward this resolution to the Humboldt County Board of Supervisors explaining the rationale for the resolution and requesting formal approval of the change by the Board of Supervisors at a public meeting held within 60 days after submission and after the resolution has been posted in accordance with the law.
- 4. The Superintendent will notify the Humboldt County Elections Office that the District is prepared to pay the expense of mailing notice of approval of the change in election date by the Humboldt County Board of Supervisors as required by Elections Code 10404.S(e).
- 5. If the consolidation of election is approved by the Board of Supervisors, the date of that election will be moved to the first Tuesday after the first Monday in November 2018 and each subsequent board member election will be held two years thereafter in November of even years.

#### Summary

On March 10, 2017, the Humboldt County Board of Supervisors received Resolution No. 1002-2017 from the Kneeland School District requesting the district election cycle be held in evennumbered years. Pursuant to Elections Code, Section 10404.5 (d)(1), the following is an impact analysis of the effects that may result due to the consolidation.

Kneeland School District, which has approximately 273 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Because of significantly lower turnout by the voters, the district must change to even-numbered year elections no later than 2022 according to Elections Code, Section 14052. If the change is approved, the district will experience a savings in future even-numbered year elections.

#### Fiscal Impact, Districts

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

In the November 2003 Uniform District Election (UDEL), Kneeland School District had one governing board member position on the ballot. The cost per voting opportunity for the UDEL was \$.50, and the district was charged \$135. The average cost of the past 3 statewide general elections held in even numbered years is \$.25 per voting opportunity. Kneeland School District would have paid approximately \$68 for the contest had it appeared on a statewide general election ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. When there is less sharing of voters or ballot types, costs increase to the remaining districts and at times, a

district is responsible for the full cost of a ballot type. The likelihood of a district bearing the entire cost of a ballot type will increase for districts that remain in odd-numbered years.

### Fiscal Impact, County

As districts move from odd to even-year elections, there will be an overall cost increase including costs due to additional ballot types, a longer ballot, and the probability of a two page ballot. On March 10, 2017, the Humboldt County Board of Supervisors received a resolution from the Mattole Unified School District requesting the district election cycle be held in even-numbered years. Pursuant to Elections Code, Section 10404.5 (d)(1), the following is an impact analysis of the effects that may result due to the consolidation.

The Mattole Unified School District, which has approximately 380 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Since there is no election to compare results, Mattole Unified School District does not fall below the threshold set forth in Elections Code § 14052, and it is not mandatory for it to switch to even-numbered years at this time. However, Election Code §1302(b), allows the governing body of a school district the ability to transition to even-numbered year elections regardless of whether it experiences decreased voter turnout or not. Therefore, any school district can move.

#### **Fiscal Impact, Districts**

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

In the November 2009 Uniform District Election (UDEL), the Mattole Unified School District had three governing board member positions on the ballot. The cost per voting opportunity for the UDEL was \$.41, and the district was charged \$478. The average cost of the past 3 statewide general elections held in even numbered years is \$.25 per voting opportunity. The Mattole Unified School District would have paid approximately \$285 for the contest had it appeared on a statewide general election ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. This can lead to an increase in voter drop off, that is, voters failing to make their way through all of the information and through all of the races on the ballot.

#### **Summary**

On March 10, 2017, the Humboldt County Board of Supervisors received a Resolution No. 030917-1 from Pacific Union School District requesting the district election cycle be held in even-numbered years. Pursuant to Elections Code, Section 10404.5 (d)(1), the following is an impact analysis of the effects that may result due to the consolidation.

Pacific Union School District, which has approximately 3,275 registered voters, currently participates in odd-numbered year elections. The district wants to reduce future election costs by moving to even-numbered year general elections. Pacific Union School District does not fall below the threshold set forth in Elections Code, Section 10452, and it is not mandatory for them to switch to even-numbered years at this time. However, Elections Code 1302(b) allows the governing body of a school district the ability to transition to even-numbered year elections regardless of whether they experience decreased voter turnout or not, so any school district can move.

#### **Fiscal Impact, Districts**

Many jurisdictions participate in even-numbered year statewide elections (federal, state, county and cities) and share the costs. The portion attributable to federal, state and county, which on average is approximately 87% of the total cost of an even-numbered year election, is absorbed by the county. Therefore the amount charged to each local jurisdiction, i.e. cities, schools and special districts, is much lower in an even-numbered year.

In the November 2003 Uniform District Election (UDEL), Pacific Union School District had two governing board member positions on the ballot. The cost per voting opportunity for the UDEL was \$.50, and the district was charged \$3,025. The average cost of the past 3 statewide general elections held in even numbered years is \$.25 per voting opportunity. Pacific Union School District would have paid approximately \$1,625 for the contest had it appeared on a statewide general election ballot.

Other districts not changing to even-numbered years may see an increase in expenses. There are times when jurisdictions don't have sufficient nominees to go to election. When there is less sharing of voters or ballot types, costs increase to the remaining districts and at times, a district is responsible for the full cost of a ballot type. The likelihood of a district bearing the entire cost of a ballot type will increase for districts that remain in odd-numbered years.

## Fiscal Impact, County

As districts move from odd to even-year elections, there will be an overall cost increase including costs due to additional ballot types, a longer ballot, and the probability of a two page ballot. The size of the voter information guide will increase as will the costs for mailing the voter guide and vote-by-mail ballots. Additional staff and extra help hours will be expended for logic and accuracy testing, programming, and processing ballots. Though districts will continue to be billed for their share in election costs, theirs is a much smaller percentage of total costs. The County's actual costs are expected to increase.

Elections Code, Section 15372, states the elections official shall prepare a certified statement of the results of the election and submit it to the governing body within 30 days of the election. Because governing board members of special and school districts would take office on the first Friday in December following the district general election, Elections Code, Section 10511(a), requires the elections official to declare the elected candidate or candidates no later than the Monday before the first Friday in December, which will shorten the canvass period for elections in even-numbered years from 30 days to 27 days. Automated scanning and sorting equipment to assist staff with processing vote-bymail ballots would be required.

## CHANGE OF ELECTION DAY OF THE GOVERNING BOARD AND REQUESTING THE BOARD OF SUPERVISORS FOR THE COUNTY OF HUMBOLDT TO AUTHORIZE CONSOLIDATION WITH THE NOVEMBER ELECTION DURING EVEN-NUMBERED YEARS

WHEREAS, §§ 1302(b) and 10404.5 of the Elections Code permit. Tripidad Union School District to change its election day with the approval of the Board of Supervisors of the County of Humboldt;

WHEREAS, it is the intent and desire of the Governing Board of the Trinided Union School Olarica to provide its constituents with the lowest possible cost while promoting the increasingly efficient and effective use of government resources; and

WHEREAS, by changing the next governing board election from November, 2017 to November, 2018, the costs of an election would be deferred for an additional calendar year;

WHEREAS, in order to comply with the mandate of SB 415 (Elections Code § 14050 et seq.), requiring political subdivisions that have had a significant decrease in voter turnout to hold their elections only on the same day as a statewide election.

# NOW, THEREFORE, BE IT RESOLVED, DECLARED, DETERMINED AND ORDERED AS FOLLOWS:

Section 1. That pursuant to Elections Code §§ 1302(b) and 10404.5, the Governing Board hereby, by this resolution, changes its election from the First Tuesday after the First Monday in November of each odd-numbered year to the First Tuesday after the First Monday in November of each even-numbered year; and, further, that the election shall be consolidated with all other elections held throughout the territory on that day.

Section 2. That terms of officeholders shall be extended as necessary, but no more than twelve months.

Section 3. That the Registrar of Voters shall cause, at district expense, a notice to be mailed to all registered voters in Trinided Union School District. informing them of the change of election date specified herein and of the resultant changes in terms of the elected officeholders.

Section 4. This resolution shall become operative upon approval by all of the above-named Board of Supervisors pursuant to Elections Code §§ 1302(b) and 10404.5.
