The intent of the content of the Human Rights Commission (HRC) resolution on Diversity and Immigration Status is spot on and very important. However, Human Rights should not be dependent on the holder of any political office, no matter how far-sighted the office holder may be. The principles of human rights are permanent and eternal. They should not be subject to reinterpretation of a new office holder in 2018, for example. Indeed, human rights must transcend the term of any individual office holder, such as the Sheriff.

Hopefully, the HRC will revisit the resolution that we passed unanimously on April 6, 2017 in order for it to become timeless and have the chance to stand for all time.

The clarification in said resolution calling for non-capricious due process is very useful. Nonetheless, as a parent of Hispanic children, I hope that eventually the HRC position will state explicitly that our intent is that non-violent undocumented parents of US citizen children shall not be subject to efforts by Humboldt County Law Enforcement or other social service or other personnel to cause such parents of American children to be deported or equivalent wording. American children need their parents at home and not be fearful for their security and safety!

When undocumented people have doubts about the motivations of local authorities, they do not tend to report crimes or be in contact with any authorities and the standards of living of all residents of Humboldt County may be negatively impacted. Humboldt County must be safe for all of our children and their families!
