This requirement is from California's Government Code, a section that Environmental Health does not oversee. It appears to be statute under the authority of those overseeing the planning review process, gathering general hazardous substance information. From that I surmise that Humboldt County Planning is looking for the information reference in the statute excerpt, below:

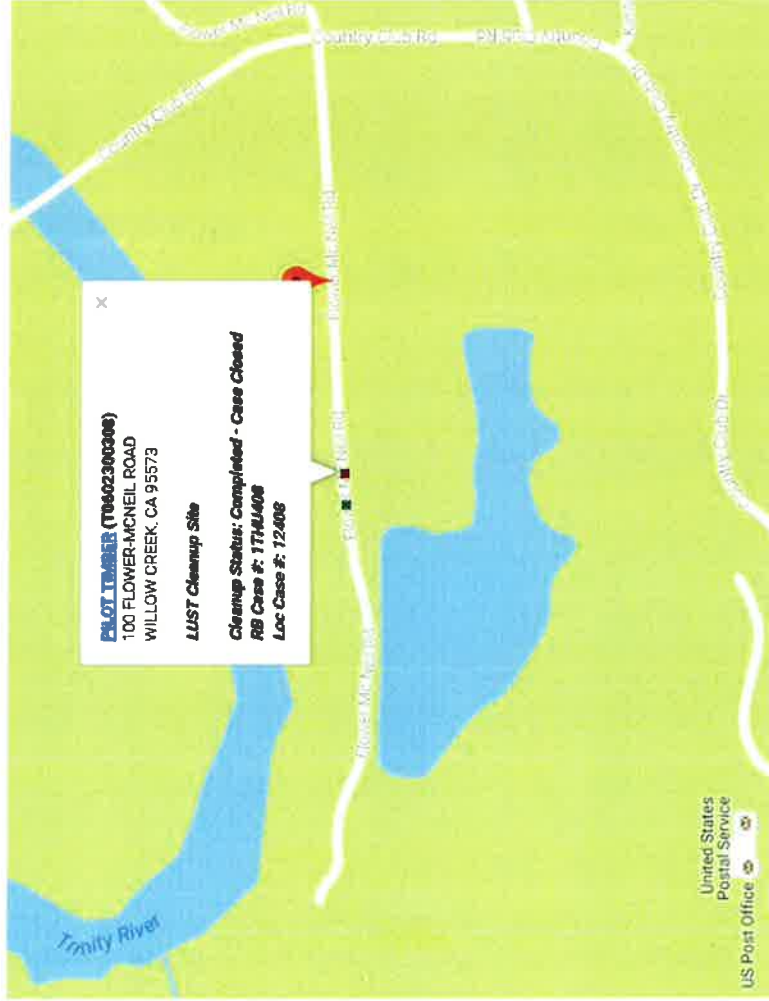
