#### **RECOMMENDATIONS:**

That the Board of Supervisors:

- 1. Review the attached membership application for Cindie Fonseca.
- 2. Appoint Cindie Fonseca to the HC-WDB in accordance with the HC-WDB bylaws for a term of two years, effective immediately.

#### SOURCE OF FUNDING:

Workforce Innovation and Opportunity Act administrative funds.

#### DISCUSSION:

The HC-WDB is a commission, appointed by the Board of Supervisors, required by the Workforce Innovation and Opportunity Act (WIOA) to oversee the workforce system and WIOA funds that come into Humboldt County, the Local Workforce Investment Area. The mission of the HC-WDB is to bring together resources to meet employer and employee needs and advance the prosperity of local communities. WIOA requires certain public agencies and labor unions to be members of the HC-WDB and for that membership to be balanced with an equal number of public and private sector appointees with the exception that the private sector is at least 51 percent of the HC-WDB membership.
