<u>DISCUSSION</u>: A vacancy is occurring on the Forestry Review Committee and the "Notice of Vacancy" per the Board's Protocol dated April 1, 2014 has been posted. This vacancy is due to the resignation of William Kleiner. Mr. Kleiner was appointed to the Committee on January 14, 2014 with a term expiring on June 30, 2018. An appointment would fill the remainder of his term.
