

WHEREAS, Jeff was selected to the position of Acting Correctional Supervisor from May 25, 2003 until September 13, 2003; and

WHEREAS, Jeff was selected in June of 2004 for the position of Senior Correctional Officer in the Sheriff Work Alternative Program; and

WHEREAS, Jeff was selected to attend Crisis Intervention Team training on March 12, 2009; and

WHEREAS, Jeff was selected to participate in a Board of State and Community Corrections Job Analysis project in Sacramento in December of 2013; and

WHEREAS, Jeff has received "Several Letters of Commendation" from local scholastic organizations for his several presentations to local academic students; and

WHEREAS, Jeff was selected as a Prison Rape Elimination Act instructor for the Humboldt County Sheriff's Office on May 21, 2015 completing training for the entire Correctional Facility staff in 2016; and

WHEREAS, Jeff was always known for his love of training new employees and his number 1 rule, take a break when offered because you never know when the next one will be.
