DISCUSSION:

The proposed ordinance (Attachment 1) prohibits parking along a west side of Ocean View Drive (3P020) from Post Mile 0.00 to Post Mile 0.27 in the Big Lagoon area; the east side of New Navy Base Road (F3K010) from Post Mile 0.00 to Post Mile 4.642; on portions of the west side of New Navy Base Road from Post Mile 0.00 to Post Mile 4.642 on the Samoa Peninsula and the south side of Railroad Drive (4M020) from Post Mile 0.276 to Post Mile 0.675 in McKinleyville. Also the proposed ordinance prohibits parking between the hours of 10:00 p.m. and 5:00 a.m. on the west side of New Navy Base Road from Post Mile 0.00 to Post Mile 4.642, containing seven turnout areas, on the Samoa Peninsula.

The residents on Ocean View Drive in Big Lagoon have complained about parking problems on Ocean View Drive. People who believe that there is beach access from Ocean View Drive, park their vehicles along Ocean View Drive creating problems for the residents living there. After this last winter's storms, the Ocean View Drive right-of—way access to the beach has been eliminated and the public is now trespassing on private land to access the beach. The county has placed signage on Ocean View Drive and Roundhouse Creek Road warning the public there is no beach access, but often the signs are ignored. By restricting parking on the west side of Ocean View Drive and placing additional signage on the Ocean View Drive right-of-way stating there in no beach access, we hope to help remediate the parking problem. The lots on the west side of Ocean View Drive are owned by the County of Humboldt, so access to properties would not be an issue.

The parking prohibition on both the east and west sides of New Navy Base Road, and restriction to parking in the seven turnouts on the west side from the hours of 5:00 a.m. to 10:00 p.m., is proposed to prevent overnight camping on New Navy Base Road.

At the intersection of Railroad Drive and Central Avenue the width of the road is forty (40) feet from curb to curb, traveling to the west, the curb and gutter stop on the south side of the street. At that point the road narrows on the south side with fourteen (14) feet from the edge of pavement to the center line and the north side is twenty (20) feet from the center line to the face of curb. Therefore, there is no room for parking a vehicle on the south side from that point until the intersection with McKinleyville Avenue, a distance of 1,700 feet. This condition is based on traffic safety.

The proposed ordinance revision is considered a project under the California Environmental Quality Act (CEQA). This project is categorically exempt from environmental review pursuant to Section 15301 (Existing Facilities) and Section 15305 (Minor Alterations in Land Use Limitations) of the CEQA Guidelines, and the application of this categorical exemption is not barred by one of the exceptions set forth in Section 15300.2 of the CEQA Guidelines. A Notice of Exemption is included in Attachment 2.

FINANCIAL IMPACT:

The cost for the manufacturing and installation of the regulatory signs are estimated at \$130.00 per sign and is covered in the Road Fund budget. There will be no impact to the General Fund.

The recommended action conforms to the Board of Supervisors core roles of providing for and maintaining infrastructure and creating opportunities for improved safety.

OTHER AGENCY INVOLVEMENT:

California Highway Patrol enforces traffic laws on county roads.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could choose not to adopt the proposed ordinance. This alternative is not recommended since it would not improve traffic safety in these locations.

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT ADDING SECTION 431-78 RELATING TO PARKING ON OCEAN VIEW DRIVE IN BIG LAGOON, AMENDING SECTION 431-79 RELATING TO PARKING ON NEW NAVY BASE ROAD ON THE SAMOA PENINSULA, AND ADDING SECTION 431-94 RELATING TO PARKING ON RAILROAD DRIVE IN MCKINLEYVILLE TO TITLE IV OF THE HUMBOLDT COUNTY CODE

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. Sections 431-78 and 431-94 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code are added as shown on the attached pages.

SECTION 2. Section 431-79 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code is amended as shown on the attached pages.

SECTION 3. This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.

Good afternoon Mr Reeves,

I am following up on an issue that my wife and I brought up to Ryan Sunberg in which he had us contact you. We have been plagued by people accessing the beach in front of our house. There are several issues from invasion of privacy in our own home, theft of packages and plants in pots on our porch, auto break ins, camping, hit and runs (three of our own vehicles and one to a friend visiting), collisions with parked cars, blocking our driveway and the neighbors, litter daily, picking flowers out of our yard, excess speeding (children and pets are not safe), people using our yard and across the street as their bathroom, loud music/partying and general run ins with people who we ask politely not to do the above stated. There is a sign that the county posted at the intersection of our road and Roundhouse Creek road. The sign says NO BEACH ACCESS. Why should we be threatened on our own property when all the county has to do is enforce the sign that you have already put at the end of the road and put up enforceable parking signs.

There is no reason other than the cost that the beachgoers cannot use the County park that has ample parking. Since the cost has risen from three dollars to five dollars the parking in front of our house has increased tenfold. There is another issue that the road has eroded almost to the point that it is not safe to walk down below the house and guardrail. The beachgoers have chosen to cut a trail around the eroded area on to our property to allow passage. When they get hurt they will surely sue Humboldt County or us. What do we have to do to get signs posted NO Parking except residents? In many counties along the California coast the county puts out the signs in beach neighborhoods to curb the trouble stated above. Not only is it dangerous for people accessing the beach thru our property and the derelict road but the County is losing hundreds of dollars a month to parking in front of our homes.

Please get back to me and let us know a reasonable timeline in which we can get an answer to a very tough situation. My next call will be to the local televisions station to run a piece on this. I know your department is very busy and we appreciate the work you do. I know we a but a blip on the radar but for us the situation hands out daily grief.
