Subject: Advance Salary Step Request for Wayne Tomasini, Road Maintenance Supervisor, from Range 393, Step B to C (4/5 vote required)

RECOMMENDATION(S):

That the Board of Supervisors approve an advance salary step increase for Wayne Tomasini, Road Maintenance Supervisor (1200 325, 0204, 393) from step B to C, starting September 10, 2017, the first day of Mr. Tomasini's promotion, pursuant to Section 7 of the Humboldt County Salary Resolution. (4/5 vote required)

SOURCE OF FUNDING: Roads Fund (1200 325)

DISCUSSION:

On April 27, 2017, the Road Maintenance Supervisor of the Rohnerville Road Crew resigned. Mr. Tomasini was a Road Maintenance Worker III at the time and he agreed to cover the duties until a new Road Maintenance Supervisor could be hired. On June 13, 2017, your Board agreed to compensate Mr. Tomasini for these additional duties; Board Order C-19 (Attachment 1).

On September 10, 2017, Mr. Tomasini was promoted to Road Maintenance Supervisor. The Department of Public Works is requesting that Mr. Tomasini be paid at 393, step C, per Section 7 of the Salary Resolution.

Subject: Assignment of Wayne Tomasini, Road Maintenance Worker III, as Road Maintenance Supervisor (4/5 vote required)

RECOMMENDATION (S): That the Board of Supervisors:

Authorize compensation for Wayne Tomasini, as if he had been promoted to the classification of Road Maintenance Supervisor from June 18, 2017 through September 30, 2017, or until the position is permanently filled; pursuant to Memorandum of Understanding between the County of Humboldt and the American Federation of State, County and Municipal Employees (AFSCME), section 12.4. (4/5 vote required).

SOURCE OF FUNDING: Roads Fund

DISCUSSION:

The Road Maintenance Supervisor of the Rohnerville Crew resigned his position effective April 27, 2017. Wayne Tomasini, Road Maintenance Worker III, has agreed to accept the additional duties of Road Maintenance Supervisor until such time as the position is permanently filled and should be compensated accordingly during this period.

FINANCIAL IMPACT:

There are sufficient funds in the Roads Fund (1200325) budget to cover the \$249.60 biweekly salary increase. This will not impact the General Fund.
