Partnership HealthPlan of California Commission Appointment

<u>RECOMMENDATION(S)</u>: That the Board of Supervisors re-appoint Herrmann Spetzler and appoint Sherri Provolt to represent Humboldt County on the Partnership HealthPlan of California Board of Commissioners.

SOURCE OF FUNDING: Federal and State Medi-Cal dollars

<u>DISCUSSION</u>: As part of the 2012/13 state budget, the State of California authorized expansion of Medi-Cal managed care into the twenty-eight rural counties that currently provide Medi-Cal benefits on a fee-for-service basis only.

On May 14, 2013, the Board of Supervisors adopted Ordinance 2501 (Attachment 1) authorizing the County of Humboldt to join the Partnership HealthPlan of California, a regional County Organized Health System (COHS) model of Medi-Cal managed care. The COHS model has been shown to be an effective Medi-Cal managed care model for improving patient health care outcomes for Medi-Cal recipients, with a focus on prevention and primary care, and allows for local representation in its governance structure.

Humboldt County is allocated three representatives on the Partnership HealthPlan of California Commission (Commission), based on the number of Medi-Cal beneficiaries enrolled in the HealthPlan. Ordinance 2501 enacting Title V, Division 9, Chapter 1 of the County Code, Section 591-3 states that: "The members appointed by the Humboldt County Board of Supervisors shall serve at the pleasure of the

board and shall be selected as follows: (1) One member shall be the Director of Health and Human Services or Director's designee. (2) Additional members will be nominated by local health care providers that serve Medi-Cal beneficiaries. The Director of Health and Human Services will receive and evaluate nominations and make recommendations to the Board of Supervisors".

This item is for the Board to appoint two members to represent Humboldt County on the Commission (Attachment 2). The Director of Health and Human Services received five applications (Attachments 3,4,5,6,7). Personal contact information has been redacted to protect the privacy of candidates, as agenda items are posted online. All five candidates were evaluated pursuant to the ordinance and all five are qualified.

The director recommends the board re-appoint Herrmann Spetzler, Chief Executive Officer of Open Door Community Health Centers to a second four-year term. Open Door Community Health Centers operates twelve community clinics in Humboldt County and is the area's largest safety net provider, serving more than 55,000 patients each year.

The director recommends the board appoint Sherri Provolt, Chief Executive Officer of United Indian Health Services (UIHS). Working closely with nine tribal governments, UIHS provides a full spectrum of outpatient health care services, serving the native communities of Humboldt and Del Norte Counties. Ms. Provolt currently serves as Program Director with the California Rural Indian Health Board, and is also a member of North Coast Health Leadership Team (CEO Roundtable) and the Humboldt Accountable Community for Health Governance Committee. She is life-long resident of Humboldt County and a Yurok Tribal Member.

Mr. Joseph Rogers is also a qualified candidate, with forty years of health care experience in Humboldt County. Currently Chief Executive Officer of Hospice of Humboldt, Mr. Rogers is a member of the North Coast Health Leadership Team (CEO Roundtable) and a licensed pharmacist. He has an extensive background in hospital administration, including as Chief Operating Officer of Redwood Memorial Hospital and Director of Pharmacy for St. Joseph Hospital, as well as experience in quality improvement, financial management and patient satisfaction. Mr. Rogers has served on numerous local and state boards and committees and is a life-long resident of Humboldt County.

Mr. Dennis Leonardi is also a qualified candidate, having served four terms on the St. Joseph Hospital Board of Trustees since 2002, currently as Chair, as well as the board of directors for Redwood Memorial Hospital and numerous board and committees. He is also a member of North Coast Health Leadership Team (CEO Roundtable), is a local business owner, and has an extensive history of civic volunteerism.

Patricia Tillotson is a qualified candidate as well. Currently employed as a medical office assistant with county public health, Ms. Tillotson has previous school board experience and has expressed a passion for serving the community.

Each Commissioner appointed by the Board will serve a four-year term on the Commission.

The Commission is also soliciting participation on several advisory committees. These advisory committees do not require board appointment. Medi-Cal patients and Humboldt County residents not appointed by the board to serve as Commissioners who would like a voice in the operation of the health plan may consider serving on one of the following advisory committees: Physician Advisory, Provider Advisory, Consumer Advisory, and the Quality/Utilization Advisory Committee.

<u>FINANCIAL IMPACT</u>: There is no additional financial impact to the County General Fund associated with the recommendation before your board. This action supports the board's strategic framework by protecting vulnerable populations and creating opportunities for improved safety and health.

OTHER AGENCY INVOLVEMENT: Partnership HealthPlan, clinics, hospitals and other Medi-Cal health care providers

<u>ALTERNATIVES TO STAFF RECOMMENDATIONS</u>: The board could elect not to appoint the recommended candidates, to solicit further applications or to appoint other individuals.

PARTNERSHIP HEALTHPLAN OF CALIFORNIA COMMISSION

CHAPTER 1

591-1. INTENT.

Partnership HealthPlan of California Commission ("commission") is a multicounty commission that has created a managed health care plan for Medi-Cal recipients. The purpose of this chapter is to authorize the County of Humboldt to join the existing commission. This will allow the implementation of a county organized health system in Humboldt County as authorized by Welfare and Institutions Code § 14087.54. (Ord. 2501, § 1, 05/14/2013)

The commission has a proven record of improving health care access to its members, who are Medi-Cal recipients, and improving Medi-Cal reimbursement rates to health care providers. The commission links each member with a primary care provider and has been successful in reducing inappropriate use of emergency rooms, providing appropriate levels of inpatient care for its members, developing innovative case management programs and arranging for the provision of an enhanced level of local health care services. (Ord. 2501, § 1, 05/14/2013)

The commission will negotiate an exclusive contract with the California Department of Health Care Services authorizing the expansion of the Partnership HealthPlan of California into Humboldt County. This expansion is expected to occur on or about June 1, 2013. (Ord. 2501, \S 1, 05/14/2013)

591-2. AUTHORIZATION TO JOIN COMMISSION.

Pursuant to Welfare and Institutions Code § 14087.54, the Humboldt County Board of Supervisors hereby authorizes the County of Humboldt to join the commission. (Ord. 2501, § 1, 05/14/2013)

591-3. MEMBERSHIP OF COMMISSION.

Commission representation shall be based on the number of Medi-Cal beneficiaries enrolled in the HealthPlan in each county as follows: one commissioner per zero to ten thousand beneficiaries; two commissioners per ten thousand to twenty-five thousand beneficiaries; three commissioners per twenty-five thousand to forty thousand beneficiaries; and four commissioners per more than forty thousand beneficiaries. (Ord. 2501, § 1, 05/14/2013)

The members appointed by the Humboldt County Board of Supervisors shall serve at the pleasure of the board and shall be selected as follows: (Ord. 2501, \$ 1, 05/14/2013)

- (1) One member shall be the Director of Health and Human Services or Director's designee. (Ord. 2501, § 1, 05/14/2013)
- (2) Additional members will be nominated by local health care providers that serve Medi-Cal beneficiaries. (Ord. 2501, § 1, 05/14/2013)

The Director of Health and Human Services will receive and evaluate nominations and make recommendations to the Board of Supervisors. (Ord. 2501, § 1, 05/14/2013)

591-4. TERM OF OFFICE.

The term for the commissioners shall be for four-year periods. Nothing herein shall prohibit a person from serving more than one term. Each commission member shall remain in office at the conclusion of that member's term until a successor member has been selected and installed into office. An office shall become vacant if a board member discontinues to function in the area from which appointed, or fails to attend three meetings in a row of the commission. (Ord. 2501, § 1, 05/14/2013)

591-5. POWERS AND DUTIES OF COMMISSION.

Pursuant to the provisions of Section 14087.54 of the Welfare and Institutions Code as it exists on the date of adoption of this ordinance, the commission shall: (Ord. 2501, § 1, 05/14/2013)

- A. Have the power to negotiate the exclusive contract with the California State Department of Health Care Services as specified in Section 14087.5 of the Welfare and Institutions Code, and to arrange for the provision of health care services provided under Chapter 7, Part 3, Division 9 of the Welfare and Institutions Code; (Ord. 2501, § 1, 05/14/2013)
- B. Be considered an entity separate from the county of Humboldt; (Ord. 2501, \S 1, 05/14/2013)
- C. File the statement required by Section 53051 of the Government Code; (ord. 2501, \$ 1, 05/14/2013)
- D. Have the power to acquire, possess, and dispose of real or personal property, as may be necessary for the performance of its functions, to employ personnel and contract for services required to meet its obligations, and to sue or be sued; and (Ord. 2501, § 1, 05/14/2013)
- E. Have all the rights, powers, duties, privileges, and immunities conferred by Article 2.8 of Chapter 7, Part 3, Division 9 of the Welfare and Institutions Code in addition to those previously specified in this section. (Ord. 2501, § 1, 05/14/2013)

591-6. OBLIGATIONS OF COMMISSION.

Pursuant to the provisions of Section 14087.54(d) of the Welfare and Institutions Code as it exists on the date of adoption of the ordinance codified in this chapter, any obligations of the commission, statutory, contractual, or otherwise, shall be the obligations solely of the commission and shall not be the obligations of the County of Humboldt. The commission shall do business as the Partnership HealthPlan of California. (Ord. 2501, § 1, 05/14/2013)

591-7. COMMITTEES.

The commission may establish advisory committees from time to time for any purpose that will be beneficial in accomplishing the work of the commission. (Ord. 2501, § 1, 05/14/2013)

591-8. TERMINATION OF MEMBERSHIP.

The commission shall continue to represent Humboldt County until such time as the Humboldt County Board of Supervisors terminates the representation. To terminate the representation, the Humboldt County Board of Supervisors or its designee shall provide ninety-day notice to other participating counties and the State Department of Health Care Services, as specified in Welfare and Institutions Code § 14087.54(g). (Ord. 2501, § 1, 05/14/2013)

591-9. SEVERABILITY.

If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portion of the ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and every section, subsection, sentence, clause, or phrase thereof, irrespective of the fact that one or more section, subsection, sentence, clause, or phrase be declared unconstitutional or invalid. (Ord. 2501, § 1, 05/14/2013)

The Humboldt County Board of Supervisors is seeking nominations to fill one seat on the Partnership HealthPlan Board of Commissioners. <u>Partnership HealthPlan of California</u> is the health plan for Medi-Cal patients in Humboldt and 13 other counties around the state. It is a county-organized health system governed by a 33-member Board of Commissioners, of which three individuals are appointed to represent Humboldt County.

At this time the Board of Supervisors is looking to fill one seat.

Commission members serve **4-year terms**. The Board of Commissioners meets **bi-monthly** on the **fourth Wednesday** of every *even* month from 10 am to 2 pm, with the exception of the December meeting which will be held on the first Wednesday of the month. The first meeting of the appointees' term will be Dec. 6, 2017.

Commissioners are asked to participate on two sub-committees, with various meeting schedules, and an annual full-day strategic planning retreat in February. The successful appointee can attend meeting in-person or via video conference. Commissioners serve without compensation, but may receive a stipend and travel allowance from the health plan.

If you are interested in serving on the Commission, please <u>fill out an application</u> and submit it <u>no</u> <u>later than October 18, 2017</u>. The Director of Health and Human Services will receive and evaluate nominations and make recommendations to the Board of Supervisors. An appointment will be made in November.
