#### PUBLIC NOTICE

On November 14, 2017, during its regularly scheduled Board meeting, the Humboldt County Board of Supervisors adopted Ordinance No. 2587, which amended Section 311-7 of the Humboldt County Code by reclassifying lands in the Phillipsville area within Assessor Parcel Numbers (APNs) 214-181-017 and 214-181-018 currently zoned (CH-D-Q) Highway Service Commercial, Design Control, Qualified to C-2-D-Q Community Commercial, Design Control, Qualified. The Q-Qualified Zone includes provisions to ensure compatibility with the CR - Commercial Recreation General Plan Land Use designation that applies to the site, and to retain the development standards of the CH Zone as recommended by the Planning Commission. The area described is also shown on the Humboldt County Avenue of the Giants Zoning Map 11b. The new zone will become effective thirty (30) days after the date of adoption.
