OF THE BOARD OF SUPERVISORS COUNTY OF HUMBOLDT

WHEREAS, Mitch Gratz will be retiring on December 31, 2017 after 30 years of employment service to the Humboldt County Sheriff's Office Custody Services Division; and

WHEREAS, Mitch was first hired on January 12, 1988, by Sheriff Dave Renner as a Correctional Officer, assigned to the old linear facility; and

WHEREAS, Mitch was promoted to a Correctional Officer II on January 22, 1989; and

WHEREAS, Mitch was appointed as the Jail Transportation Officer on March 18, 1990 responsible for conducting daily transports of inmates to and from the county jail to the Arcata Courts, Fortuna Courts, and the Garberville Courts; and

WHEREAS, Mitch was then appointed as an Acting Senior Correctional Officer from November 8, 1993 through February 1, 1994; and

WHEREAS, Mitch was promoted to the permanent position of Senior Correctional Officer on May 22, 1994; and

WHEREAS, Mitch was assigned to the County IT Division to assist with the transition from "Typewriter" Bookings to a new "Computer" management system which Mitch was responsible to oversee the implementation of the new system and the coordination of training all the staff; and

WHEREAS, Mitch was appointed as an Acting Supervisor on April 9, 1995; and

WHEREAS, Mitch was promoted to the full time position of Correctional Supervisor June 18, 1995; and

WHEREAS, Mitch was recognized by then Sheriff Gary Philp for his role on our Sheriff's Office "In House Recruitment Program" which assisted in the recruitment efforts at that time; and

WHEREAS, Mitch was assigned on February 1, 2004 to the Sheriff's "Use of Force Committee."; and

WHEREAS, Mitch was assigned to his current assignment of the Sheriff's Work Alternative Program (SWAP) Supervisor where he was responsible for running the Sheriff's Rohnerville Farm, Sheriff's Wood-Lot, Cal-Trans Work Crews and all the other various functions of S.W.A.P.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors, Sheriff William Honsal, and the staff of the Humboldt County Sheriff's Office hereby commend Correctional Supervisor Mitch Gratz for his 30 years of service, and together, wish him success in his retirement.
