DISCUSSION:

Pursuant to Government Code §27322.2 reproductions of recorded documents shall be made and a true copy of the document shall be stored in a safe and separate location. The amount budgeted for the conversion of images for the 2017/2018 fiscal year is insufficient. A transfer of funds from the Recorder's Record Conversion fund 1310 will allow us to bring our image conversion current. This request meets the Boards strategic framework by ensuring sustainability and investing in the future.

FINANCIAL IMPACT:

The County Board of Supervisors approved an additional recording fee pursuant to Government Code §27361.4(a) in order to defray the cost of converting the County Recorder's documents. The \$28,000 requested will be used to reproduce images on film. Two sets of film will be produced, one copy to be held in the Recorder's office, and one copy will be stored off site in a secure location. The current balance of fund 1310 is \$623,949. There is sufficient funding available for this project, and the general fund will not be impacted.
