On January 23, 2018, the Humboldt County Board of Supervisors adopted Ordinance No. 2590, which amends the zoning of property in the Garberville area known as 216-133-001, 216-141-006, 216-144-003, 223-013-003, and 223-013-004, by rezoning these lands out of Agriculture Exclusive with a combining zone specifying a minimum parcel size of 160 acres (AE-B-5(160)) to Timberland Production Zone (TPZ). 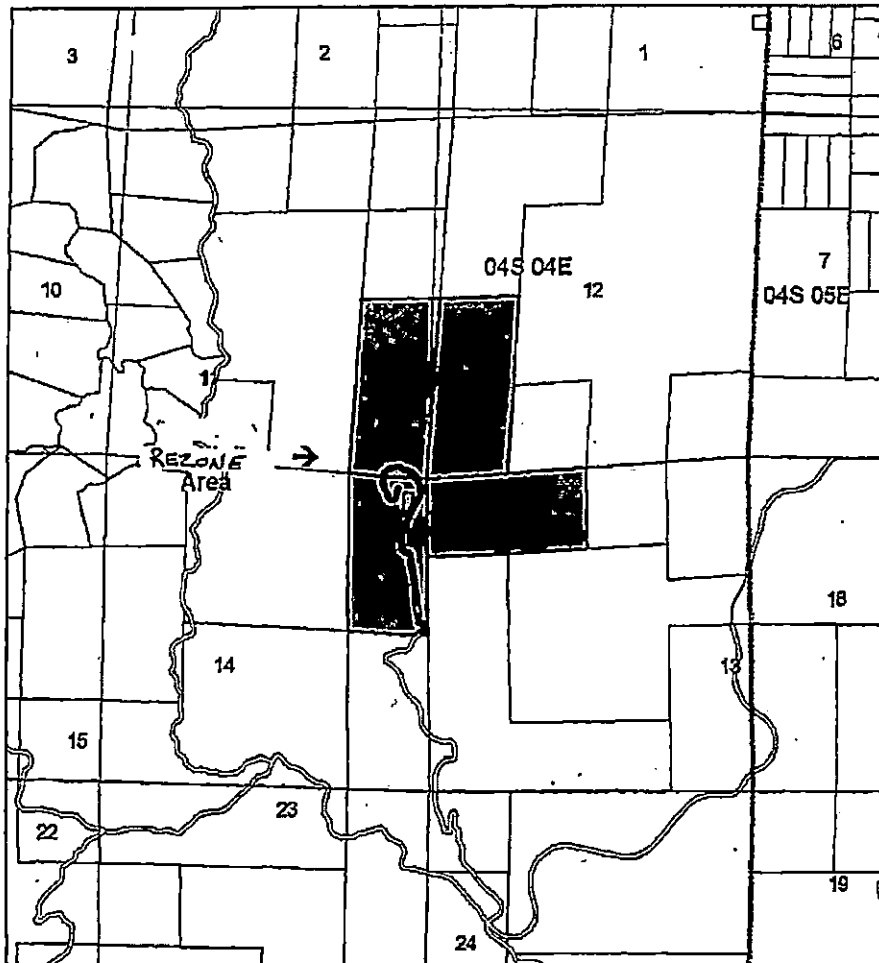
