<u>RECOMMENDATION(S)</u>: That the Board of Supervisors rescind Resolution No. 09-28 and adopt Resolution No. ______ authorizing the County Administrative Officer/Purchasing Agent and Public Works Director/Road Commissioner/County Engineer to approve change orders in accordance with Public Contract Code 20142.

SOURCE OF FUNDING: ADA Compliance Fund and Public Works Project Funding

DISCUSSION:

California State Law (Public Contract Code Section 20142) prescribes the maximum amounts for change orders to construction contracts that can be delegated by the Board to the County Administrative Officer/Purchasing Agent and Director of Public Works or other county official. The state adjusts the maximum limits allowed in this section of the law over time in order to keep the limits current.

On April, 28, 2009, the Board of Supervisors approved Resolution No. 09-28 (Attachment 1) which authorized the Director of Public Works to approve change orders under construction

contracts for public buildings and other structures to the adopted state prescribed limits of Public Contract Code Section 20142. In addition, on March 4, 2014, your Board adopted the County of Humboldt's Purchasing Policy, which authorizes the Purchasing Agent (or her designee) to negotiate and execute Public Works agreements under sections 12.2 and 12.3. These two sections are for public projects greater than \$1,200 up to the current Public Contract limit of \$45,000, and for public projects greater than \$45,000 to the current limit of \$175,000 respectively. Authorizing the County Administrative Officer/Purchasing Agent to execute Public Works (public projects) agreements but not authorize change orders for such projects was an oversight, which was discovered during Americans with Disabilities Act (ADA) barrier removal public projects at county facilities.

Therefore, staff recommends the Board rescind Resolution No. 09-28 and adopt the attached resolution granting authorization to the County Administrative Officer/Purchasing Agent and the Public Works Director/Road Commissioner/County Engineer to approve change orders in accordance with Public Contract Code 20142.

<u>FINANCIAL IMPACT</u>: There is no impact to the General Fund. This item supports your Board's Strategic Framework by providing and maintaining infrastructure; and, fostering transparent, accessible, welcoming and user friendly services.

Subject: CONTRACT CHANGE ORDER LIMITS SIGNATURE AUTHORITY

<u>RECOMMENDATION(S)</u>: That the Board of Supervisors adopt the attached resolution authorizing the Public Works Director/Road Commissioner/County Engineer to approve change orders in accordance with Public Contract Code 20142.

SOURCE OF FUNDING: Public Works Project Funding

<u>DISCUSSION</u>: California State Law (Public Contract Code Section 20142) prescribes the maximum amounts for change orders to contracts that can be delegated by the Board to the Director of Public Works or other County Official under construction contracts. The State adjusts the maximum limits allowed in this section of the law over time in order to keep the limits current.

The County of Ilumboldt, by Board Action on August 31, 1982, authorized the Director of Public Works to approve change orders under construction contracts for public buildings and other structures to the adopted State prescribed limits of Public Contract Code Section 20142. Since that time the language of Public Contract Code Section 20142 has been revised by the State, however when Humboldt County adopted the code section it was adopted with the exact language of Public Contract Code Section 20142 in 1982. Thus, while the state has increased the amount for larger projects and changed the language of the code section, Humboldt County has retained the lower limits and outdated language.

Attachment 2: California Public Contract Code Section 20142

PUBLIC CONTRACT CODE - PCC

DIVISION 2. GENERAL PROVISIONS [1100 - 22355] (Division 2 enacted by Stats. 1981, Ch. 306.)

PART 3. CONTRACTING BY LOCAL AGENCIES [20100 - 22178] (*Part 3 added by Stats.* 1982, Ch. 465, Sec. 11.)

CHAPTER 1. Local Agency Public Construction Act [20100 - 20929] (Chapter 1 added by Stats. 1982, Ch. 465, Sec. 11.)

ARTICLE 3.5. Counties [20120 - 20147] (Heading of Article 3.5 amended by Stats. 1984, Ch. 1128, Sec. 8.)

(a) The board of supervisors may, by ordinance, resolution, or board order, authorize the county engineer, or other county officer, to order changes or additions in the work being performed under construction contracts. When so authorized, any change or addition in the work shall be ordered in writing by the county engineer, or other designated officer, and the extra cost to the county for any change or addition to the work so ordered shall not exceed five thousand dollars (\$5,000) when the total amount of the original contract does not exceed fifty thousand dollars (\$50,000), nor 10 percent of the amount of any

original contract that exceeds fifty thousand dollars (\$50,000), but does not exceed two hundred fifty thousand dollars (\$250,000).

(b) For contracts whose original cost exceeds two hundred fifty thousand dollars (\$250,000), the extra cost for any change or addition to the work so ordered shall not exceed twenty-five thousand dollars (\$25,000), plus 5 percent of the amount of the original contract cost in excess of two hundred fifty thousand dollars (\$250,000). In no event shall any such change or alteration exceed two hundred ten thousand dollars (\$210,000).
