DISCUSSION:

On Dec. 19, 2017 your Board appointed Kaleb Cockrum as the Interim Public Defender. Mr. Cockrum left his position as Supervising Attorney for Conflict Counsel to accept this appointment. Kelly Neel formerly served as the Interim Supervising Attorney to replace Mr. Cockrum. Ms. Neel has since been appointed as a judge, opening another vacancy for this position. Since Ms. Neel's appointment, Megan O'Connell was

assigned to perform the principal duties of Supervising Attorney for the office of Conflict Counsel in accordance with Section 7 of the Salary Resolution. Ms. O'Connell has already been working in the position beyond 10 days, and is expected to remain in this position until the department fills it with a permanent hire or takes other action.

FINANCIAL IMPACT:

The increased monthly costs of a Supervising Attorney (Class 0610, Range 550, Step A) from a Deputy Public Defender IV, Megan O'Connell, (Class 0604, Range 521, Step B) is \$1,150.31. Approval of the continuance of the acting Supervising Attorney is estimated at \$4601.24 for the rest of fiscal year (FY) 2017-18 and will be funded through the Conflict Counsel's budget (1100-246). This position was already budgeted for in FY 17-18 and this item is not expected to impact the General Fund.

This conforms to your Board's Strategic Framework by providing core services in a ways that safeguard the public trust through investing in county employees.

The Board could decline to grant out of class pay for Ms. McConnell. This is not recommended as Ms. O'Connell is already taking on the principal duties of another position outside her current class.
